SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation

If inhaled, remove person to fresh air. If not breathing give artificial respiration. If breathing is difficult give oxygen.

Skin contact

Flush skin with plenty of soap and water for at least 15 minutes while removing contaminated clothing and shoes. Seek medical advice if irritation persists.

Eye contact
