RESOLUTION 2026-01

*A Resolution of the Board of Trustees of the West Point Cemetery
District (District) Modifying District Bylaws*

Resolved by the Board of Directors of the District:

WHEREAS, the West Point Cemetery District is mandated under the law to maintain its properties for lawful burials of District residents or those who can demonstrate historical or familial ties to the West Point community, and is not authorized to convey property rights, rather is exclusively authorized to provide *Interment Rights*; and,

WHEREAS, the District wishes to memorialize that, pursuant HSC § 8113.5 (a), the District chooses to authorize disposition of multiple remains per plot with appropriate charges as below described; and,

WHEREAS, the District wishes to impose a limit on vertical monuments per plot;

Now, therefore the district resolves as follows:

- **Revisions to District fee structure shall take effect on 1 July 2026; and**
- **To incorporate the following language into the District Bylaws:**

MISSION STATEMENT

The West Point Cemetery District, an independent special district funded by taxpayers and sale of interment rights, provides affordable interment services for District residents and those who can demonstrate historical or familial ties to the West Point community. We strive to maintain the beauty and dignity of the West Point and Sandy Gulch cemeteries while preserving their historical and cultural value for the benefit of all.

WEST POINT CEMETERY DISTRICT

CHARGES FOR INDIVIDUAL INTERMENT RIGHTS:

CASKET: \$400 plus a \$250 endowment care fund fee = \$650

CREMAINS: \$250 plus a \$150 endowment care fund fee = \$400

NUMBER OF INTERMENTS ALLOWED PER PLOT

<NOTE> Each Additional Interment Is Subject to Full Interment Fee.

5' X 10' Plot: Maximum two (2) caskets, if so reserved at time of Interment Right purchase and excavated per District Burial Guidelines; or, one (1) casket plus two (2) containers of cremains, or, four (4) containers of cremains;

5' X 5' Cremation Plot: Maximum two (2) containers of cremains;

NUMBER OF MONUMENTS ALLOWED

5' X 10' Plot: Maximum two (2) upright monuments or two (2) flush markers.

5' X 5' Cremation Plot: Maximum one (1) upright monument or two (2) flush markers.

This Resolution is hereby adopted and approved by the Board of Trustees of the West Point Cemetery District.


