Leadership Bonus Qualifications

Our leadership bonuses are earned at the positions of Gold & Platinum Consultant.

GOLD CONSULTANT

To achieve the bonus of this position ALL of the following must be met by 11:59 pm PST on the last day of the qualifying month:

- A minimum of 15 personal IBO packages.
- A minimum of 3 Silver Consultants. There must be at least 1 Silver in 3 separate legs.
- At the time of promotion, the Gold Consultant must be in good standing on his/her monthly fee.

Any refunds or chargebacks within 30 days by any agent whose enrollment made the promotion possible will subsequently cause the bonus to be forfeited, reversed, withdrawn, and/or deducted from the account of the Gold Consultant.

Important Leadership Bonuses are paid monthly (posted on the Friday after the 15th of every month) at the Gold & Platinum (1-8 Star) levels. You must reach the rank status by the end of the month but you must also <u>"HOLD the position" through the 7</u>th of the following month in order to receive the leadership bonus (\$750 – 100K).

Effective July 1, 2022, Gold Consultants will have a minimum 1k residual payment. Gold Consultants will have a 1k guarantee (residual pool + \$750 leadership bonus = \$1,000 minimum).

PLATINUM CONSULTANT

To achieve the bonus of this position and other Platinum levels ALL of the following must be met by 11:59 pm PST on the last day of the qualifying month:

- A minimum of 300 IBO's in the organization.
- No more than 1/3 counting from any particular leg.
- The number of IBO's that make up the total for the promotion have to be in good standing; IBO's must be current on their monthly fee every 30 days.

Example: An agent is promoted to 1 Star Platinum with 500 IBOs in their organization on June 7th. Effective July 1, 2022, Platinum Consultants will have a minimum \$2,500 residual payment. Platinum Consultants will have a minimum \$2,500 guarantee (residual pool + leadership bonus = \$2,500 minimum). Platinum(s) must be at least Gold qualified to receive guarantee.
