Recognizing that no residents came forth with any complaints or question regarding the county assessors report on personal property, that was tabled last month, the mayor entertained a motion to accept the report as written. Motion made to accept made by Alderman Beauclair, seconded by Alderman Hanson, passed. The auditor will forward that information to the assessor.

Auditor reported that roll offs are reserved for cleanup. Will arrive Friday May 16th and be picked up Monday May 19th. Information about refuse has been posted in the last 2 issues of city notices and is also on the Post Office Bulletin board.

Auditor reported that he has not had a chance to look for more information regarding the deeded skating rink land and the original agreement. Tabled.

Mayor stated that he has confirmed that we are going to use Banyon Data Systems and the information for upgrading our utility billing system and the program information should arrive in the mail shortly. This will include up to 400 hours of online training and assistance.

NEW BUSINESS:

Question was asked about port-a potties and security for Davenport Days. As in the past, the city will pick up the cost for 2 port-a potties for the event, to be ordered by the Park Board, Lions or Fire department and the cost of up to 2 sheriffs deputies to work security for the event and street dance.

701 Spirit Bar and Grill, Kindred, asked by proxy from the mayor for a permit to serve alcohol during Davenport Days. The permit would be for Saturday June 21st, good from 2 pm until 12 midnight and on the park grounds only. Motion to grant permit made Alderman Gjestvang, seconded by Alderman Hanson, passed.

Interstate Power Systems submitted a bid for the maintenance of the pumphouse generator. Another bid was submitted from Butler Machines. Discussion ensued, Motion to accept contract offer in the amount of \$600/year from Interstate Power Systems made by Alderman Beauclair, seconded by Alderman Hanson, passed.

Mayor requested each Alderman and Steve Hans to come up with a list of what streets need the most repair attention and to rank their need, to be delivered at the next city council meeting for discussion.

Auditor tasked to contact Midwest Inspectors (also handles city building permits) for information/addresses of the parties that built/ moved in one of the new houses, so they may be contacted about fixing the damage done to the property across the street when putting in the waterline.

Motion to adjourn made by Alderman Hanson, seconded by Alderman Gjestvang. Passed
