**Special Event Indemnification**

THIS SPECIAL EVENT INDEMNIFICATION is to provide indemnification to THE VILLAGE PEDDLER FESTIVAL and VILLAGE PEDDLER EVENTS, LLC, its successors and assigns (TVPF), and Lake Metroparks its Board of Park Commissioners for Lake Metroparks, officers, directors, agents, employees and volunteers, by the \_\_\_\_\_ (the “vendor”) on the date herein below written by the vendor executing this Agreement.

WHEREAS, TVPF and Lake Metroparks are conducting a special event entitled The Village Peddler Festival (the “Event”), which will feature various attractions, including but not limited to, arts and crafts, specialty foods, informal dining, and general merchandise related to the Event:

Indemnification and Release. The Vendor further agrees to waive, release, forebear from and hold harmless the TVPF and Lake Metroparks and indemnify TVPF and Lake Metroparks from and against any and all damages, costs or expenses, including all attorney’s fees, and all suits, claims and actions, at law or in equity, that may arise as a result of or in the course of the Event from any act of God, nature or other events beyond the reasonable control of TVPF and Lake Metroparks, its officers, directors, agents, employees and volunteers. This indemnity and waiver of liability shall survive the term or termination of this Agreement as to any claims arising before the expiration or termination of this Agreement.
