Following up on the first Public Meeting held in November 2025, this Second Public Meeting will afford the surrounding community an opportunity to review the detailed project proposal and the environmental and engineering studies that have been completed

The proposal to engage in the project and the project itself is subject to the provisions of the *Environmental Protection Act (Act)* Part V.0.1 and Ontario Regulation 359/09 (Regulation). Pursuant to the Act and Regulation, the facility, in respect of which this project is to be engaged in, is a utility scale Class 3 solar facility. If approved, this facility would have a total maximum name plate capacity of 154 MW. The project location is described in the map below.
