Approval of September 9, 2025, Police Commission Meeting Minutes

Meeting minutes have been included for your review and approval.

September, October, and November 2025 Activity Reports

Approval September, October, and November 2025 Claims

September, October, and November 2025 claims are attached for review and approval.

2025 YTD Budget & Cash Asset Reports

In reviewing the 2025 Budget vs. Actual reports from January 1 to November 30, 2025, WHPS has received \$2,466,512.30 or 91.93% in income with expenses of \$2,550,421.42 or 95.06%. The budget currently shows a net income of -\$83,909.12.

As a reminder, WHPS received \$190,088 in 2024 as income for Public Safety Aid from both cities. The current balance of the Public Safety Aid is \$166,916. There is \$120,000 of that aid included in the Projected Income for the 2025 budget. This projected income was designated to offset the cost of the 11th officer. The Public Safety Aid fund balance will be reduced at the end of FY2025 to reflect the offset of these funds in general fund spending.

Balances of other accounts: Crime Prevention \$18,568.21, Federal Forfeiture \$165,024.11, Reserves \$2,236.84, Capital Outlay \$96,298.26, Severance \$34,421, and Public Safety Aid \$166,916.

2025 YTD Accrued Vacation/Comp/Sick Time

The accrued vacation, compensation, and sick time reports are enclosed for review. There is one request for carryover into 2026 for use in February and one request for payout for discussion and approval.

Update on LMAC Records Management agreement

Hennepin County is now signed on as the 14th member of LMAC. The agreement is now making it's way through the proper channels for signatures of all agencies. Once signed, we can move to the next phase of records management planning.

Audits

WHPS has successfully completed our BCA IT audit, the Automated License Plate Reader audit, and the NCIC audit. We passed all audits, with a couple tasks yet to complete for the IT audit to be in full compliance.

Staffing and Personnel Update

Ben Anderson is still working a modified assignment, but has been selected as the next Investigator/Detective for WHPS. Final logistics are still being worked out with his return date to full duty yet to be determined. He has moved into the Investigator office and Investigator Zilles will resume his duties at the DTF office.

Mason Splichal started in October and is progressing through his field training program.

Austin Ward joined WHPS as a Reserve and is progressing through his training. He has already been an active participant in events and Reserve duties. An additional applicant will be in for an interview in the near future.

Chief DuRose has successfully completed EMR training as required by POST.

Vehicle Updates

We purchased a used Nissan Pathfinder for use by our Drug Task Force agent for \$37,869.06. This was budgeted as a replacement in 2025 and forfeiture funds were used. The previous DTF Jeep Cherokee is now the training/admin vehicle. The Ford Edge and a utility trailer were sent to auction recently and we received \$4600 from their sales.

Bluetooth holster sensors

We have ordered Bluetooth holster sensors for uniformed duty holsters. This sensor will automatically activate body-worn cameras if the firearm is released from the holster. This technology makes activation automatic, removing the responsibility of the officer to activate the camera in dynamic situations. The purchase of these sensors was made possible through the donation received from the McGarry's Golf Tournament.

Hennepin County Attorney Traffic Stop Charging Policy

Hennepin County Attorney Mary Moriarty implemented a policy on "Non-Public-Safety Traffic Stops" on October 15, 2025. This policy was put in place without discussion from Hennepin County law enforcement agencies. The Hennepin Chiefs Association held a press conference to provide messaging about our feelings about the policy and it's potential impact on crime and accountability in Hennepin County. Since implementation of the policy, the Hennepin Chiefs board has met with the County Attorney's Office and will continue to do so. This policy may have minimal impact on WHPS as it only applies to felony offenses that result from these traffic stops. We will continue to make traffic stops and arrest/charge offenders as appropriate.

Office hours adjustment request

I would like to request approval to keep WHPS offices closed on December 26th. Administrative staff would like to utilize leave time if offices were to remain closed. Phones would roll to Hennepin County and duty staff would still be available to assist anyone who comes to the building for assistance.

Liability Coverage Waiver form

The Police Commission has always elected to waive the monetary tort on liability coverage. Current law allows a person to only receive \$500,000 per event, even if the claim should be much higher. WHPS has waived the monetary tort to not cap its liability in the event a claim is filed. Doing so would save legal costs for a lawsuit over \$500,000. Official action is needed from the Police Commission documenting this action. Chair Spencer's signature is required as the Police Commission Chair. I would ask that the Police Commission approve waiving the monetary tort and Chair Spencer sign it.

MN Chiefs of Police Foundation grant

WHPS was awarded a \$2,000 grant from the MN Chiefs of Police Foundation to help cover costs associated with the 1st Annual Cops and Bobbers occurring in 2026. A resolution for accepting the grant is included.

1. Call to Order.

Pursuant to due call and notice thereof, a regular meeting of the West Hennepin Public Safety (WHPS) Board of Commissioners was called to order at 8:04 a.m. by Chair Brad Spencer.

5. Update on LMAC Records Management Data Transfer with CentralSquare

On September 3, 2025, Director DuRose and participating LMAC agencies met with Hennepin County Sheriff's Office (HCSO) representatives regarding HCSO joining the LMAC group as the 14th agency. HCSO and HC IT will meet with County administration. It is hoped that by the next Police Commission meeting, the agreement is signed to get HCSO on as the 14th agency. The next step will be to get our data into South Lake Minnetonka Police Department (SLMPD), then the LMAC agencies can start looking at what the next records management system will be. There's already talk among several participating LMAC agencies about two or three possible systems.

6. Discussion of Lift Assists at Care Facilities Update

On August 25, 2025, Sgt. Ebeling and Maple Plain Fire Chief Denneson had a follow up meeting with Haven Homes to continue discussing reducing first response calls at the facility. Since that meeting, calls for service have decreased. WHPS will begin tracking calls for service on October 1, 2025, and present those reports to City of Maple Plain on a quarterly basis. City of Maple Plain adopted an amendment to city code to include a fee schedule for lift assist service calls. Fees will be administered by the City of Maple Plain. This will affect both Haven Homes and Comfort Haven.

7. 2026 Budget Discussion

Director DuRose presented the original 1st draft to two additional draft versions in memo and table format.

Draft #2 reduces the overall budget by \$10,629 and the cities' total contribution by \$13,128. There is a cost increase due to Paid Family Leave premiums, reductions in uniform allowances, dental premiums, MSRS year-end payout, the removal of purchasing 2 new Flock cameras and technology based on new estimates and an income increase of TZD income.

Draft #3 reduces the budget by approximately \$51,000 if the candidate being backgrounded for the open full-time police officer position passes their background and physical and psychological exams. If they do not move forward, another hiring process would need to be completed that could potentially bring a more costly candidate. Public Safety Aid revenue will also be factored in at the end of 2025 to cover the cost of 11th officer who began employment as a licensed police officer in March. That figure is estimated to be approximately \$90,000. This option reduces the budget by \$62,589 and the cities' total contributions by \$90,089.

Motion by Maas-Kusske, seconded by Burak, to approve budget draft #3, subject to the hiring of the candidate being backgrounded and if he is not hired, then a special meeting will be held in October. Three voted aye – Spencer, Maas-Kusske, Burak. One voted no – McCoy. Motion carried.

Motion by McCoy, seconded by Spencer, to hold a special meeting on October 21, 2025, at 4 p.m. in WHPS' conference room, pending candidate currently being backgrounded does not get hired. All voted aye. Motion carried.

Director DuRose proposed separating out the Capital Improvement Plan (CIP) fund into its own cash fund. He spoke to WHPS accountant Andrew Berg who agreed it would be a good idea. Expense account 402 – Capital Improvement would be a transfer out, making it its own cash account. This way, each year Director DuRose will present both an operating budget and a Capital Improvement budget outlining the expected expenditures. The Capital Improvement budget is largely for squad cars. This change was supported by the Commission and City Administrators.

New Business

8. Full-Time Police Officer Hiring Process

WHPS made a conditional offer to a candidate for the open full-time police officer position. The candidate completed their background packet and turned it in to WHPS backgrounder on August 15, 2025, at WHPS office. WHPS' backgrounder is currently doing reference checks. If all goes well with the background, the candidate will be scheduled for medical and psychological exams. Director DuRose expects the candidate's background to be completed in the next few weeks.

9. Staffing and Personnel Update

Investigator Zilles continues working both investigations and the drug task force. An officer's recent injury has led to some staffing issues, creating some overtime shifts to ensure coverage. Director DuRose has been working closely with League of MN Cities regarding the officer injured during the Battle of the Badges softball game. The workman's comp claim was denied due to a state statute that states very clearly, unless an employee is forced or assigned to do community events and recreational events, they are not covered. Director DuRose is assisting the employee with looking into the appeal process through the Department of Labor. In the meantime, he has told this officer that WHPS will support him in any way as he goes through his follow-up

appointments and allow him back at any point that his restrictions allow. WHPS will know more tomorrow after his follow up appointment. If and when he can come back with restrictions, he could be put in investigations. In that case, Officer Zilles would go back to the drug task force full time. Director DuRose will continue to stay in touch with the injured officer.

10. Monthly Activity Report Format

A new monthly activity report format is being designed by Director DuRose and AA Dwinell. The new format will report crimes in a more modern fashion while sharing community event and engagement activities with the Police Commission and city councils. A draft format was not included in the Police Commission packets, but emailed to Commissioners prior to the meeting. Director DuRose reviewed the new format as a PowerPoint presentation. One suggestion was to include an additional column for year-to-date numbers. The new cover format is still in the design stage. Suggestions were to label each pie slice, change them to a bar graph so it's easier to read and due to some people being color blind, format all the information onto one page, add a column for year-to-date numbers, non-criminal vs. month. Director DuRose and AA Dwinell will continue to work on editing the new format.

11. Urban Area Security Initiative (UASI) Grant Award

This is a grant that Director Durose became aware of through the Lakes Area Emergency Management (LMAC) group and Orono Police Chief Farniok. It is administered through Hennepin County. Director DuRose, Minnetrista and Wayzata and South Lake Minnetonka Police Departments submitted applications. WHPS was awarded two grants through Hennepin County Emergency Management: \$9,136 for two pairs of night vision optics for Lakes Area SWAT usage and \$8,865 for a ballistic shield. WHPS was planning to purchase a shield with Capital Improvement funds. The purchase will not be completed until final approval from Hennepin County. Once sub grant agreements go out to the agencies for signatures and returned, the agencies will be approved to make the purchases and be reimbursed. The UASI grant focuses on emergency operations center equipment so that will be the next area Director DuRose will work on.

12. LUCAS Grant Award

WHPS has been granted a Lund University Cardiopulmonary Assist System (LUCAS) machine, a mechanical chest compression system that provides consistent, hands-free cardiopulmonary resuscitation to patients in cardiac arrest. This machine costs just over \$20,000 each. Sgt. Ebeling and Officer Vorderbruggen attended training in the use of the machine. All officers will receive training in the use of the machine but until then, it will only be deployed with officers who are currently trained in its use. Maple Plain Fire Department and North Ambulance also have LUCAS machines.

13. Bit of Grace Sensory Kits

On August 29, 2025, WHPS came into possession of several Bit of Grace sensory kits. An overview of the bags was presented to the Police Commission. They are for both adults and children having difficulty communicating with police officers while on a call for

service. Director DuRose pulled sensory items out of a bag for the Police Commissioners to see. The bags sell for \$100 each.

14. Upcoming Audits

WHPS will be working on several audits over the next month. They are a BCA IT Security audit, an Automatic License Plate Readers audit and a Juvenile Justice and Delinquency Act (JJDA) audit. The JJDA audit was held on September 2, 2025 and Director DuRose was advised that WHPS passed. The BCA IT Security audit is a questionnaire that Noah Roddy from Element Tech assisted WHPS with on September 8, 2025. Some improvements have already been made. The Automatic License Plate Readers audit will take place later today.

15. Next Scheduled Police Commission meeting.

The Police Commission will hold a special meet October 21, 2025, 4 p.m. in WHPS' conference room if the police officer candidate being backgrounded does not pass his background, medical and psych tests. If that meeting is canceled, a Police Commission is scheduled to meet Tuesday, December 9, 2025, 8 a.m., in WHPS' Conference Room, if needed.

16. Adjourn

Motion by McCoy, seconded by Burak, to adjourn. All voted aye. Motion passed. The meeting adjourned at 9:20 a.m.

SUBJECT: SEPTEMBER 2025 ACTIVITY REPORT



The purpose of this report is to give the reader a quick overview of the activities of the Public Safety Department each month. It also compares monthly and year-to-date information to the reader.

The report is broken down into five categories, as defined by the Criminal Justice Reporting System.

CRIMINAL-- Criminal is broken down into Part I and Part II crimes.

Part I includes crimes against persons versus crimes against property; criminal homicide, forcible rape, robbery assault, aggravated assault, burglary -breaking or entering, larceny-theft, larceny analysis, motor vehicle theft and arson.

Part II includes other assaults, forgery and counterfeiting, fraud, embezzlement, stolen property, buying, receiving, possession; vandalism, weapons, carrying, possessing, etc.; prostitution and commercialized vice, sex offenses; drug abuse violations, gambling, offenses against the family and children, driving under the influence, liquor laws, drunkenness, disorderly conduct, vagrancy, all other offenses, suspicion, curfew and loitering laws - persons under 18; and runaways - persons under 18.

TRAFFIC-- Includes violations of the road and driving laws.

PART III-- Lost and Found: Includes lost and found persons, animals, and property, and stalled and abandoned vehicles.

PART IV-- Casualties: Includes all motor vehicle crashes, boating, and snowmobile; public home occupational accidents, fires, suicides, sudden deaths, burning permits, and burning violations.

PART V-- Miscellaneous Public: Includes open doors, gun permit applications, suspicious activities, animal complaints, motorist assists, alarm calls, parking complaints, house checks, driving complaints, civil matters, family disputes, department assists.

The balance of the report shows the total number of incidents handled, miles driven and how the Public Safety Department received calls. If anyone should desire more detailed statistical data, please contact my office.

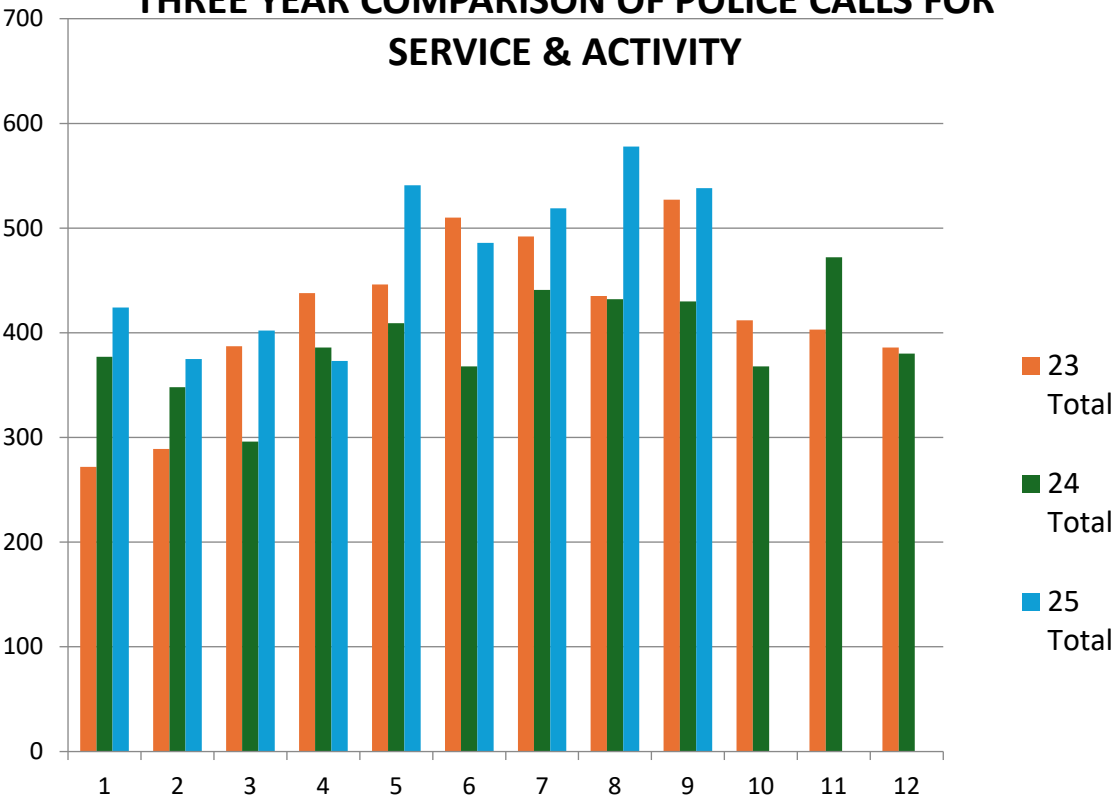

September 2025 Activity Report

Year to Date Activity Report

At the end of September 2025, West Hennepin Public Safety (WHPS) handled year-to-date a total of 4,236 incident complaints. For the month of September; 327 incidents occurred in the City of Independence and 166 in the City of Maple Plain.

The Criminal Part I and Part II cases for both cities have been highlighted for your review on the attached documents.

Suspicious Activity

September 1

4000 block of Gateway Boulevard, Maple Plain. Officer was on routine patrol and observed a gate to the Kwik Trip construction site was open. Officer checked the area and determined nothing appeared to be disturbed. The gate was made secure.

Traffic Complaint

September 2

County Road 110/County Road 6, Independence. Officer was dispatched to a traffic complaint where a possible weapon was displayed. Reporting parties advised there was a vehicle tailgating them. The vehicle passed and they thought they had observed a black revolver pointed upward. Officer was able to locate the driver who denied having a gun or contact with the callers.

Solicitor Complaint

September 3

5600 block of Lake Sarah Heights Drive, Independence. Officer was dispatched to a pest control salesman going door to door. Officer arrived in the area and spoke to the male. It was determined the solicitor was a juvenile. He was warned for soliciting without a permit and transported to meet his fellow salesmen.

Crash
September 4

Highway 12/County Road 90, Independence. Officer was on routine patrol and observed vehicle parts and tire tracks leading across the roundabout. There was no involved party on scene and no report made about the incident. The debris was analyzed, and vehicle make, and model was located. Video footage was reviewed and confirmed the vehicle went directly across the roundabout. Due to the quality of the footage, it's not possible to identify the vehicle or driver.

Juvenile Problem
September 6

Pagenkopf Road/County Road 90, Independence. Officer was on routine patrol and observed two ATV's driven by juveniles fail to stop at a stop sign. The two stopped upon seeing the officer's squad car. Officer spoke to the juveniles as well as their parents. All parties were advised of safety concerns and violations.

Driving Complaint
September 6

Howard Ave/Highway 12, Maple Plain. Officer was dispatched to a traffic complaint where a vehicle was struggling to maintain its lane. Officer located the vehicle and spoke to the driver. Officer observed an open THC drink and requested the driver to exit the vehicle. Officer conducted Field Sobriety Tests, which the driver performed satisfactorily. Officer conducted a probable cause search of the vehicle and located cocaine paraphernalia and an improperly packaged container of marijuana. The driver was cited for the violations.

Disturbance
September 7

Highway 12/Hitsman Lane, Independence. Officer was dispatched to a disturbance in the roadway. Officer arrived on scene and spoke to the reporting party who advised while he was turning, a vehicle almost hit him. The reporting party honked his horn, and the other vehicle followed him. The driver got out of the vehicle and the two exchanged words. The other driver left the area when he was advised the police were being called.

Theft
September 9

The purpose of this report is to give the reader a quick overview of the activities of the Public Safety Department each month. It also compares monthly and year-to-date information to the reader.

The report is broken down into five categories, as defined by the Criminal Justice Reporting System.

CRIMINAL-- Criminal is broken down into Part I and Part II crimes.

Part I includes crimes against persons versus crimes against property; criminal homicide, forcible rape, robbery assault, aggravated assault, burglary -breaking or entering, larceny-theft, larceny analysis, motor vehicle theft and arson.

Part II includes other assaults, forgery and counterfeiting, fraud, embezzlement, stolen property, buying, receiving, possession; vandalism, weapons, carrying, possessing, etc.; prostitution and commercialized vice, sex offenses; drug abuse violations, gambling, offenses against the family and children, driving under the influence, liquor laws, drunkenness, disorderly conduct, vagrancy, all other offenses, suspicion, curfew and loitering laws - persons under 18; and runaways - persons under 18.

TRAFFIC-- Includes violations of the road and driving laws.

PART III-- Lost and Found: Includes lost and found persons, animals, and property, and stalled and abandoned vehicles.

PART IV-- Casualties: Includes all motor vehicle crashes, boating, and snowmobile; public home occupational accidents, fires, suicides, sudden deaths, burning permits, and burning violations.

PART V-- Miscellaneous Public: Includes open doors, gun permit applications, suspicious activities, animal complaints, motorist assists, alarm calls, parking complaints, house checks, driving complaints, civil matters, family disputes, department assists.

The balance of the report shows the total number of incidents handled, miles driven and how the Public Safety Department received calls. If anyone should desire more detailed statistical data, please contact my office.

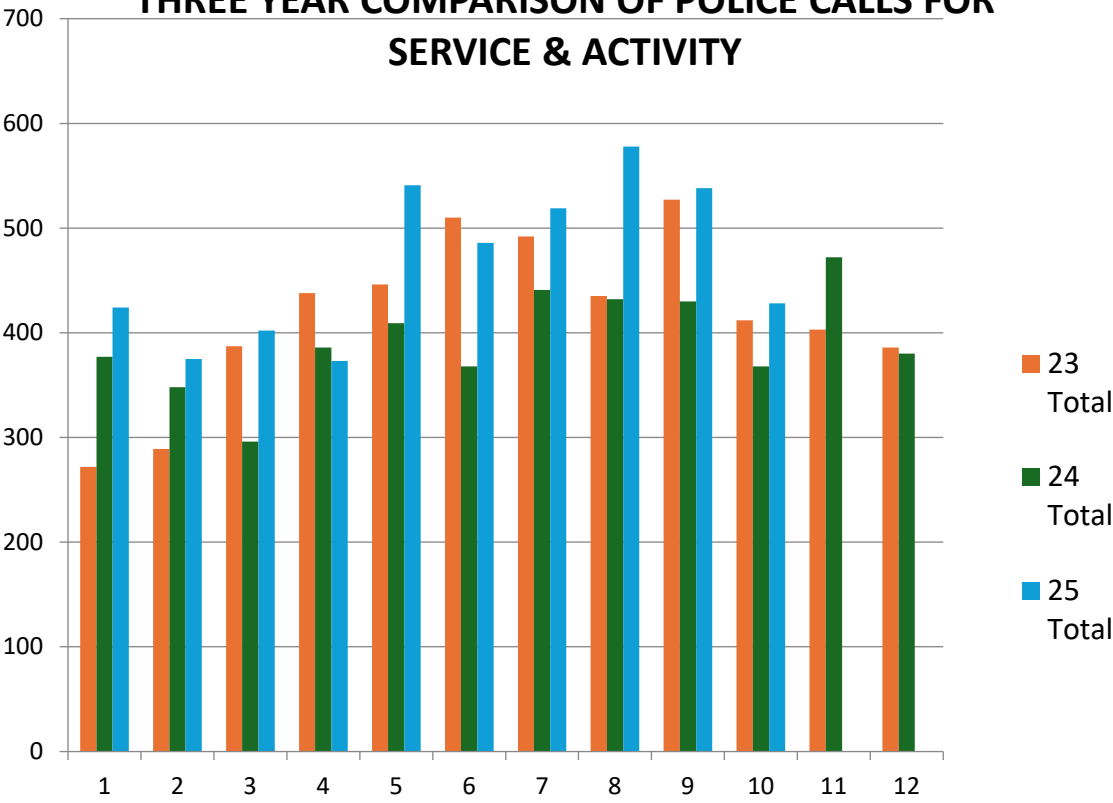

October 2025 Activity Report

Year to Date Activity Report

At the end of October 2025, West Hennepin Public Safety (WHPS) handled year-to-date a total of 4,664 incident complaints. For the month of October; 260 incidents occurred in the City of Independence and 131 in the City of Maple Plain.

The Criminal Part I and Part II cases for both cities have been highlighted for your review on the attached documents.

Animal Complaint

October 1

100 block of Kuntz Drive, Independence. Officer was dispatched to a loose horse running on Luce Line Trail. The animal owner advised they just got the horse and isn't sure if it will come back on its own. Approval was given to the animal owner to take a golf cart on the trail to locate the horse. Officer checked the area and was unable to locate the horse. A short time later, the animal owner called and advised the horse had returned.

Traffic Complaint

October 2

Highway 12/County Road 90, Independence. Officer was dispatched to a driving complaint where the suspect vehicle was reportedly passing on the right. Officer located the vehicle, initiated a traffic stop, and found the license plate was out of state and expired in January 2024. Officer spoke to the driver who advised she thought she was going to be turning, realized it wasn't her turn yet, and accidentally passed. The driver was cited for not having a MN driver's license and an Unregistered Motor Vehicle.

Forgery

5700 block of Amy Lane, Maple Plain. Officer was dispatched to take a forgery report where a check was written, mailed, then altered. The suspect wrote the check in his name and presented the check at another bank. Forwarded to investigations for follow-up.

The purpose of this report is to give the reader a quick overview of the activities of the Public Safety Department each month. It also compares monthly and year-to-date information to the reader.

The report is broken down into five categories, as defined by the Criminal Justice Reporting System.

CRIMINAL-- Criminal is broken down into Part I and Part II crimes.

Part I includes crimes against persons versus crimes against property; criminal homicide, forcible rape, robbery assault, aggravated assault, burglary -breaking or entering, larceny-theft, larceny analysis, motor vehicle theft and arson.

Part II includes other assaults, forgery and counterfeiting, fraud, embezzlement, stolen property, buying, receiving, possession; vandalism, weapons, carrying, possessing, etc.; prostitution and commercialized vice, sex offenses; drug abuse violations, gambling, offenses against the family and children, driving under the influence, liquor laws, drunkenness, disorderly conduct, vagrancy, all other offenses, suspicion, curfew and loitering laws - persons under 18; and runaways - persons under 18.

TRAFFIC-- Includes violations of the road and driving laws.

PART III-- Lost and Found: Includes lost and found persons, animals, and property, and stalled and abandoned vehicles.

PART IV-- Casualties: Includes all motor vehicle crashes, boating, and snowmobile; public home occupational accidents, fires, suicides, sudden deaths, burning permits, and burning violations.

PART V-- Miscellaneous Public: Includes open doors, gun permit applications, suspicious activities, animal complaints, motorist assists, alarm calls, parking complaints, house checks, driving complaints, civil matters, family disputes, department assists.

The balance of the report shows the total number of incidents handled, miles driven and how the Public Safety Department received calls. If anyone should desire more detailed statistical data, please contact my office.

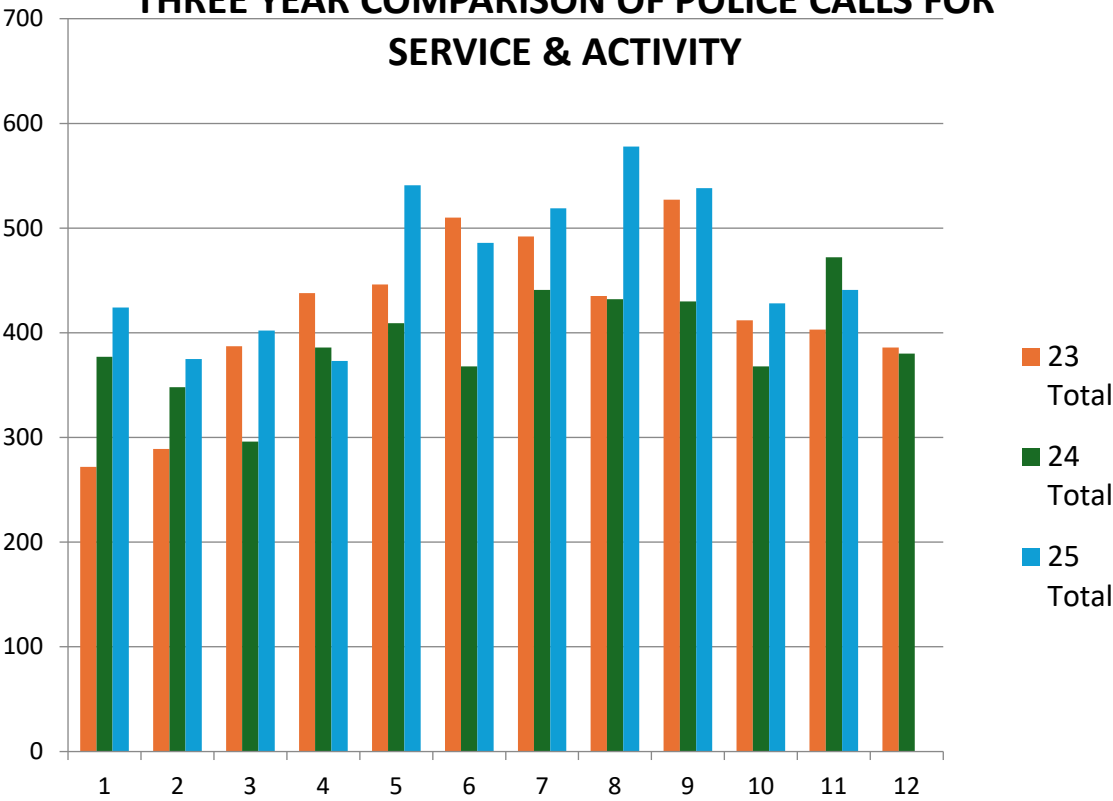

WEST HENNEPIN PUBLIC SAFETY November 2025 Activity Report

Year to Date Activity Report

At the end of November 2025, West Hennepin Public Safety (WHPS) handled year-to-date a total of 5,105 incident complaints. For the month of November; 225 incidents occurred in the City of Independence and 172 in the City of Maple Plain.

The Criminal Part I and Part II cases for both cities have been highlighted for your review on the attached documents.

DWI Arrest November 2

County Road 11/County Line Road, Independence. Officer was on routine patrol and observed a vehicle drive through the stop sign without slowing. Officer initiated a traffic stop and spoke to the driver who displayed signs of impairment. Officer observed an empty bottle of alcohol on the passenger's side floor. Field Sobriety Tests were conducted, and the driver was ultimately arrested for DWI. She provided an evidentiary breath sample that indicated 0.14. She was issued a citation for 4th Degree DWI and was released to a sober party.

Robbery November 3

1400 block of Meadow Lane, Maple Plain. Officers responded to a report of an armed robbery in the 1400 block of Meadow Lane in Maple Plain. The victim reported that they had arranged a Facebook Marketplace sale and were robbed at gunpoint during the transaction. The suspect fled the area with the item and ran into a nearby residence. Further investigation was conducted, and several items of evidence were recovered at the scene, including a handgun. A 17-year-old female from Maple Plain was taken to Hennepin County Juvenile Detention Center and booked on armed robbery charges.

Theft/Burglary
November 4

5000 block of Fern Drive, Independence. It was reported multiple theft from autos, and a burglary of a detached garage had occurred overnight. The property taken included two e-bikes, a compound bow, gift cards, and small amounts of cash. A short time later, a neighboring agency received a tip of where the stolen property might be. Ultimately, all the property was recovered at a nearby house and was returned to the owners. The suspect was arrested on a warrant and transported to Hennepin County Jail. Case was forwarded to investigations.

Burglary
November 5

7400 Maple Ponds Trail, Independence. Officer was dispatched to an attempted burglary where a neighbor called in a known trespassed male attempting to gain access to an unoccupied residence. Officer arrived on scene and determined the male left the area prior to arrival. Upon examination, a deadbolt had been drilled out and there were hinges removed from another door. Case was forwarded to investigations.

Vehicle Fire
November 6

2100 block of County Road 92, Independence. Officer was dispatched to a vehicle fire. Officer arrived on scene with Maple Plain Fire and found the fire started under the passenger seat. It was determined the fire was likely caused by an electrical shortage and the fire put itself out.

Suspicious Activity
November 7

5000 block of Oak Circle, Maple Plain. Officer was dispatched to a suspicious vehicle that had been parked in the cul-de-sac for an extended period of time. Officer arrived and observed the vehicle left prior to police arrival. A short time later, Officer was dispatched to a return call. Officer arrived on scene and spoke to the occupant of the vehicle who advised she was waiting to pick her daughter up from baby sitting at a residence.

Animal Complaint
November 8

4900 block of Main Street, Maple Plain. Officer was dispatched to a deceased squirrel that had a dart in it. Officer arrived and observed the squirrel with a green flight attached. It was determined the dart was from a blowgun. Blowguns are considered a dangerous weapon according to state statute and the City of Maple Plain prohibits the use of dangerous weapons. No suspects are known at this time.

DWI Arrest
November 9

Highway 12/County Road 92, Independence. Officer was dispatched to a traffic complaint where the suspect vehicle was swerving between lanes. Officer located the vehicle and observed it swerving and almost hitting the lane delineators. Officer initiated a traffic stop and spoke to the driver who displayed signs of impairment. The suspect was ultimately arrested for DWI and provided an evidentiary test of 0.19. Suspect was transported to Hennepin County Jail for 3rd Degree DWI.

Traffic Complaint
November 10

Highway 12/Baker Park Road, Maple Plain. Officer was dispatched to a traffic complaint where a vehicle was all over the road. Officer located the vehicle and spoke to the driver who advised he's unable to see well at night. It was found the driver's license status was revoked and the vehicle didn't have insurance. Driver was cited for the violations, and a driver evaluation form was submitted.

The juvenile male matched the description of a vandalism and damage to property suspect from previous cases. The juvenile's mother was contacted, and she responded to the scene. Video footage of the male was shown to the mother who confirmed it was her son and his signature graffiti "tag". This case was referred to investigations for possible charges and/or restitution.

Animal Complaint

8500 block of County Road 11, Independence. Officer was dispatched to a dark brown horse running on County Road 11. The reporting party had corralled it into a fenced area but was worried it would escape again. Officers located the animal owner who came and picked it up.

Welfare Check

November 14

2200 block of South Lake Shore Drive, Independence. Officer was dispatched to a welfare check on the reporting party's coworker who hadn't been seen or heard from in two days. Officer arrived and spoke to the subject who was suffering from a severe respiratory infection and had been drinking. The preliminary breath test was provided which indicated 0.271. It was determined the subject's parents were able to provide care. Resources were provided and information was given to the embedded social worker for follow-up.

Suspicious Activity

November 15

3300 block of County Line Road, Independence. Officer was on routine patrol and observed an occupied, running vehicle in a nearby parking lot after midnight. Officer made contact and was advised it was a couple talking after a date. They advised they would move along.

Trespassing

November 16

Budd Avenue/Oak Street, Maple Plain. Officer was on routine patrol and observed an individual walking along the train tracks. Officer spoke with the individual who advised she was walking her dog. Officer advised the railroad tracks are private property and spoke about the dangers of walking along the tracks. She understood and agreed to leave the area.

Crash

5400 Pagenkopf Road, Independence. Officer was dispatched to a call regarding a damaged mailbox. Officer arrived on scene and spoke to the homeowner who advised someone hit their mailbox and damaged the landscaping around it. Officer located the grill which he recognized from previous contacts with the vehicle. Officer arrived at the suspect's address and observed a truck with damage to the front end and missing a grill. Officer spoke to the owner who advised she was tired and fell asleep while driving. Due to the suspect's cooperation, the officer decided not to pursue criminal charges. A driver evaluation form was submitted on behalf of the suspect.

Suspicious Vehicle
November 17

County Road 92/Pioneer Creek Road, Independence. Officer observed an unoccupied vehicle with significant damage. The front bumper was missing, a rim was bent, it had a flat tire, the rear window was shattered out, and the rear portion of the roof was dented in. Officer located two state ID cards, and a work ID. Officer followed a typical route from the work location to the ending location and determined the vehicle was involved in a crash at Highway 12 and County Road 92 where the front bumper with the license plate still attached was found in the embankment. A Drug Recognition Evaluation was conducted which the evaluator believed the driver was under the influence of a Central Nervous System Stimulant. A search warrant was applied for, granted, and executed for a blood sample. He was then transported to Hennepin County Jail pending toxicology and charges.

Animal Complaint
November 20

Highway 12/Baker Park Road, Maple Plain. Officer was dispatched to an injured fox in the area. Officer arrived and did not locate a fox but did observe a deer that was still alive and had a broken front leg and antler. The officers safely dispatched the deer and contacted a local resident to take the deer.
