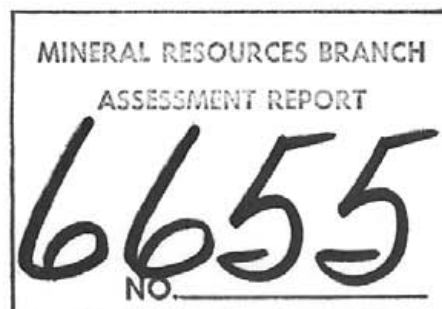


No Mineral Claims

Prospecting Report

92F / 2W



Mor Claim, Port Alberni District, British Columbia.

Location:

The Mor claim, Record Number 109(4), Port Alberni, is located on the Port Alberni Bamfield road at about mile 20. (From Port Alberni). It is made up of one unit. More specifically the southwest corner of the claim is located at the point where Parsons Creek crosses the road. (See accompanying).

Prospecting:

Two days, March 14th and 15th 1978, were spent prospecting the claim and the adjoining ground. Several traverses were made across the claim, see accompanying. Travel is extremely difficult due to the rugged terrain and heavy underbrush. In addition the country has been logged over and there are numerous deadfalls in the underbrush. All in all prospecting is extremely slow and difficult. It is felt that the claim was well covered by the traverses made.

An attempt was made to collect soil samples. This however proved almost impossible due to the depth of the humus. One silt sample was taken from a small creek near the south-

west corner of the claim. The sample was assayed geochemically for copper.

Geology and mineralization were observed in the course of prospecting.

Geology:

The claim is underlain by volcanics, andesite, with minor coarse grained basic intrusives. Outcrops are small and very scattered, however all were fairly uniform in composition, namely massive andesite, locally slightly altered.

One outcrop of massive medium coarse grained diorite was observed.

Mineralization:

The original showing was located in a rockcut on the north side of the road near where it crosses Parsons Creek. Chalcopyrite and bornite with minor malachite was found associated with quartz in very narrow shear zones. Minor mineralization was also found in the wall rock.

Chalcopyrite and malachite ^{en^{it}} was found in the bed of Parsons Creek, approximately 1,000 feet downstream from the

bridge. Mineralization was confined to a breccia zone in the andesite. It is not considered to be of significance in itself.

Other mineralization noted was minute specks of pyrrhotite in the andesite, particularly in close proximity to the original showing.

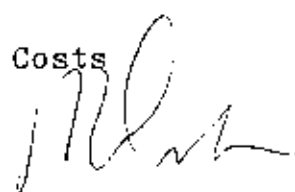

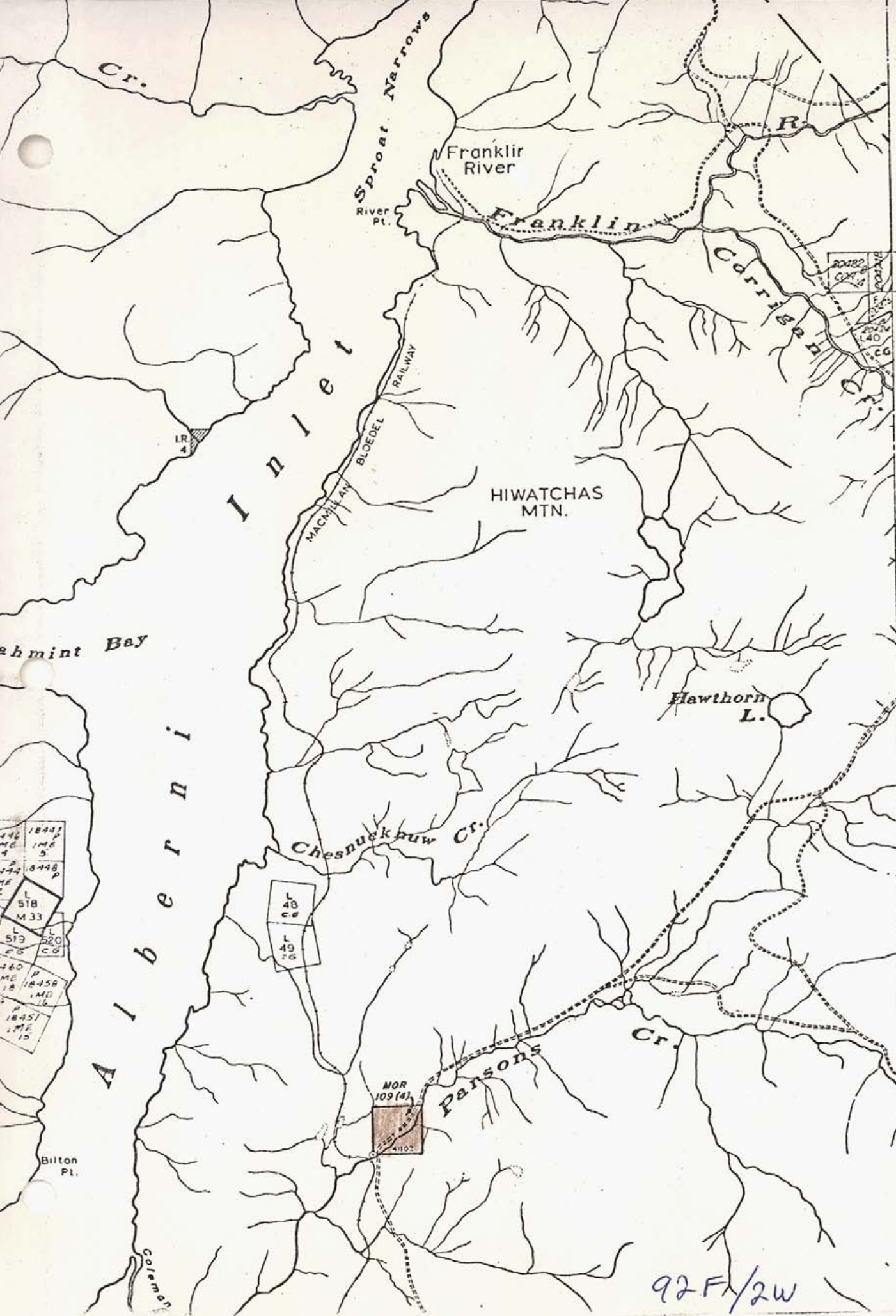

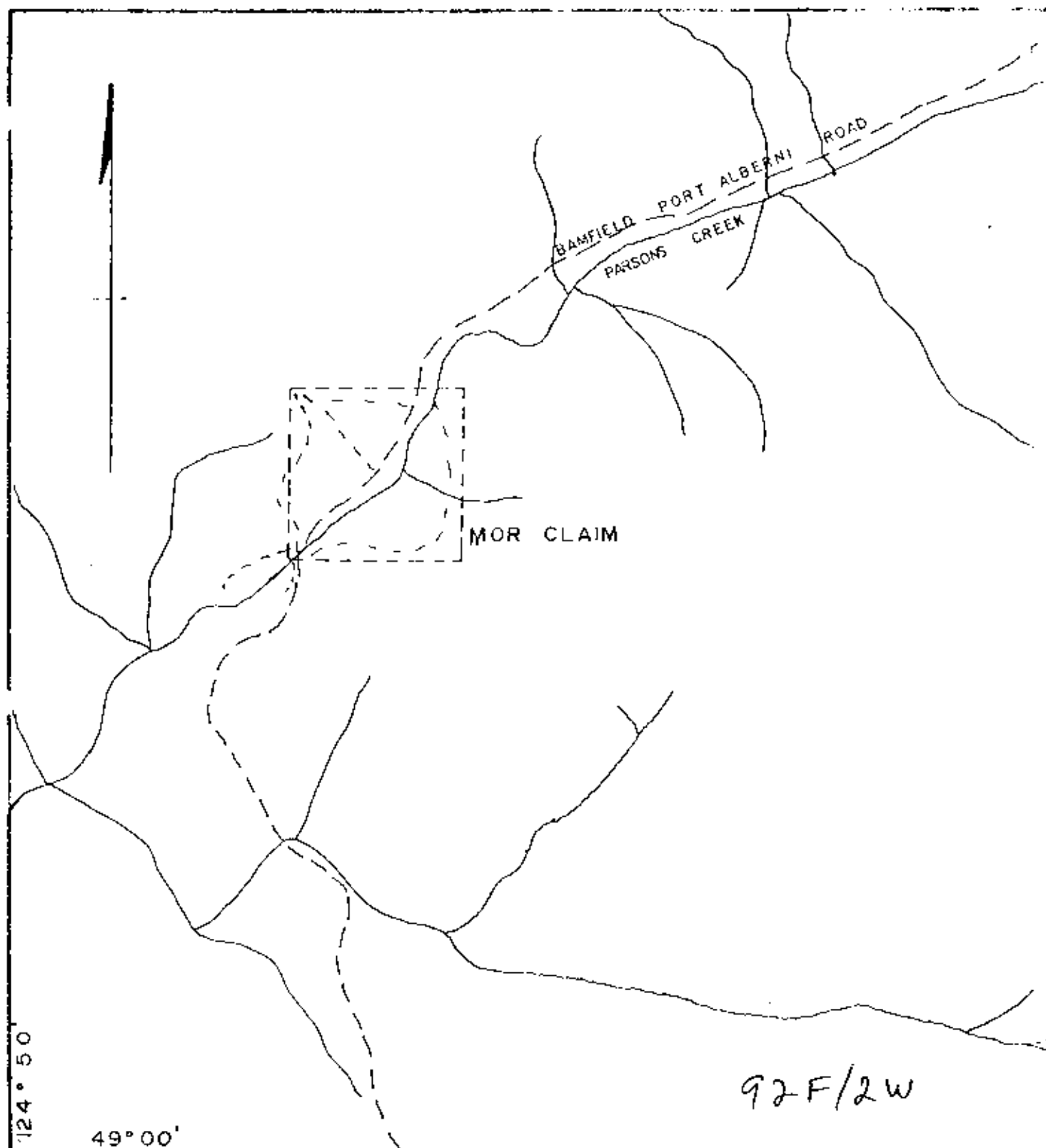
