The regular scheduled monthly board meeting was held on Monday, October 30, 2023 at 10:00am. The meeting was held in the small conference room at the village hall. Village president, Joe Burgess called the meeting to order at 10:01am.

Under correspondence, several Valier residents voiced concerns about their safety in the village in light of criminal activity that had occurred in the community. They had concerns that we do not have much police presence in the community. The board assured them that they were trying to come up with a solution but getting police to come to Valier part time has been an ongoing issue.

The village treasurer, Chris Scroggins presented a balance sheet of the current funds for the village. He discussed paying the street lighting bill out of the motor fuel tax fund. He will bring a list of his recommendations on the bank account changes at the next meeting. He also presented the claims report of bills from September 22nd to October 30, 2023. Motion was made by Gale Burzynski to accept the claims report of bills. Second was given by Kelly Bates. Motion carried. All yeas.

Committee reports were given at this time. Joe reported that there were 9 calls in the past month: 5 medical emergencies – lift assist, 1 landing zone, 1 rural structure fire, 1 illegal burn and 1 mutual aid to Barren Township-scissor lift. Joe also reported that the fire department would be participating in trick or treat night and handing out glow sticks.

The animal control report was presented. He had 2 calls from Central Dispatch and 1 social media outreach.

Joe reported for the water/sewer department. They are working on a water leak on East Johnson Street. He also stated he had a meeting with the engineer on the water tower project. Bids are being sent out and they hope to start it in February or March.


