November 20, 2023

The regular scheduled monthly board meeting was held on Monday, November 20, 2023 at 10:00am. The meeting was held in the small conference room at the village hall. Village president, Joe Burgess called the meeting to order at 10:00am.

The meeting was moved to New Business to accept the resignation of village president, Joe Burgess as he is stepping down due to taking a new full time day shift position at his outside employment. Kelly Bate made a motion to accept his resignation. Second was given by Scott Dagner. Motion carried. All yeas. The village board thanked Joe for his service and expressed they would need his advice and expertise from time to time.

The village clerk, Gina Shurtz presided over the meeting at this time and explained that after talking with the village attorney and providing a copy of the state statute to the trustees, the board would need to appoint a village trustee to fill the vacancy of the village president until the next election to be held in April 2025. Mike Moyers submitted his letter of resignation as village trustee and stated he would take the acting village president position until the next election. He also stated he would like to appoint Joe Burgess to remain on the board as a village trustee to fill his vacancy. Kelly Bate made a motion to accept Mike's resignation as village trustee and his appointment as acting village president, as well as appointing Joe Burgess as village trustee to fulfill the vacancy. Gale Burzynski seconded the motion. Motion carried. All yeas. At this time the meeting returned back to the regular agenda schedule.

Kelly Bate made a motion to approve the October 30, 2023 regular scheduled board meeting minutes and second was given by Gale Burzynski. Motion carried. All yeas.

Under correspondence, some Valier residents asked about what the village was doing about police presence in the community. Scott Dagner addressed them and the board that he had a strong candidate for a part time police patrolman and he is working with ISP and Franklin County on some police cases in town. With the passing of the new ordinances, he is hoping to see less criminal activity and more enforcement. One village resident asked about more communication from the board and acting village

Police Chief, Jake Waters was present at the meeting and stated he would be turning in his resignation on Tuesday, November 21 2023 and would also being turning in Morgan Water's resignation at the same time. He stated he would turn in the police car and any equipment when he submits his resignation. He is working 12 hours shifts at his present job and does not have the time to continue as police chief. No police report was presented at the meeting.

Scott Dagner presented 2 ordinances from the police committee to the board that would help deal with vandalism and crime in the village. The first ordinance presented was titled "Bicycles" and would repeal the current bicycle code 24-2-8.
