ORDINANCE NO. 25-460

**AN ORDINANCE AMENDING SECTION X OF ORDINANCE NO. 107, AND
AMENDMENTS THERETO (RELATED TO SECTIONS 38-4-10, 38-4-11, AND 38-4-12),
AND AMENDING SECTION 38-4-24 OF THE REVISED CODE OF ORDINANCES OF THE
VILLAGE OF VALIER, FRANKLIN COUNTY, ILLINOIS.**

BE IT ORDAINED by the Board of Trustees of the Village of Valier, Franklin County,
Illinois, as follows:

SECTION ONE: The Revised Code of Ordinances of the Village of Valier, specifically
Section X of Ordinance No. 107, and amendments thereto, is hereby amended by deleting the
current language and replacing it with the following:

SECTION X. That there be, and there are hereby, established charges and rates for the
use and services of the waterworks and sewerage system of the Village of Valier, Illinois, as
follows:

Monthly charges or rates for water service only, based upon the quantity of water used as
measured by the Village water meter serving the connection.

A monthly service charge of \$23.07 per service with billing for water consumption of the
first 1,000 gallons per month, with a \$23.07 minimum charge for Village of Valier residents and
a monthly service charge of \$24.64 per service with billing for water consumption of the first
1,000 gallons per month, with a \$24.64 minimum charge for non-Village of Valier residents.
For each additional 1,000 gallons, there shall be a monthly service charge of \$5.77 for Village of
Valier residents and a monthly service charge of \$6.16 for non-Village of Valier residents,

The service charge for the installation of a water line from the water main to meter-well,
inside the Village limits, \$900.00. (For a 3/4-inch tap)

The service charge for the installation of a water line from the water main to meter-well,
outside the Village limits, \$1,200.00.

For a permit to tap the sewer main and inspection of said tap, \$400.00.

The service charge for installation of a water meter, \$50.00.

The service charge for the reinstallation of a water meter to the same customer where
service was either voluntarily discharged or due to a default in payment, \$50.00.

A written permit shall first be obtained from the Village Board or its designee before
any tap is made to Village water or sewer lines.

SECTION TWO: The Revised Code of Ordinances of the Village of Valier, Section 38-4-24, is hereby amended by deleting the current language and replacing it with the following:

38-4-24 **BASIC USER RATE.** There shall be and there is hereby established a minimum charge and a basic user rate for the use of and for service supplied by the Wastewater Facilities of the Village of Valier.

(A) A minimum charge of **Twenty-Three Dollars and Seven Cents (\$23.07)** per month shall be applied to all users whose water consumption does not exceed One Thousand (1,000) gallons per month.

(B) A basic user rate of **Three Dollars and Forty-Six Cents (\$3.46)** per One Thousand (1,000) gallons shall be applied to all users for water consumption in excess of One Thousand (1,000) gallons per month.

(C) Any non-metered users of the wastewater facilities shall pay a minimum flat rate charge per month adequate to cover the costs of the minimum debt service charge plus the basic user rate. The Village reserves the right to require any non-metered user(s) to install metering devices on the water or sewer main to measure the amount of service supplied.

SECTION THREE: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed so far as such conflict exists.

SECTION FOUR: This Ordinance shall be effective from and after its due passage, approval, and publication as required by law.

SECTION FIVE: The Village Clerk is directed to publish this Ordinance in pamphlet form.
