Chris also presented and discussed the board financial statements as of fiscal year end April 30, 2024. A motion was made by Gale Burzynski to accept these reports and pay the claims. 

Under correspondence, Mike presented a letter from Sparklight that are internet service was going up \$5.00.

On behalf of the Valier Alumni Association, George (Ted) Farmer presented the board with a contract for the Valier Community High School monument memorial to be placed in the park with a guarantee that the Village of Valier would maintain it and not remove it for the next 99 years. After much discussion and reviewing the picture of the monument Gale Burzynski made a motion to accept the contract and Scott Dagner seconded the motion. The board members present signed the contract.

Acting village president, Mike Moyers presented the fire department report. They had 8 calls: 4 auto aid to Sesser, 2 traffic accidents in town and 2 traffic accidents out of town.

On water and sewer, the water tower rehabilitation project is complete. They had to replace the vent

on top of the water tower so that added an additional \$7,500 to the project. Plans are to inspect the water tower north of Valier and add an altitude meter so we can fill them both up as it is higher than the one in town. We had 2 water breaks on Pershing St and they were fixed.

Scott Dagner reported for the police department. He presented a police patrolman candidate, Andrew Cairel to add to the roster. Kelly Bate made a motion to accept Scott's recommendation to hire Andrew Cairel. Dave Kent seconded the motion. Motion carried. All yeas.



Under old business, bids were opened and read at the meeting for 2 village properties for sale. The first property for sale was 104 W. Flora St. One bid was received by John and Amy Prudent in the amount of \$1,100.00. Kelly Bate made a motion to accept the bid and Gale Burzynski seconded the motion. The motion carried. All yeas. The second property for sale was 304 E. Wilson, lots 2 and 3. 2 bids were received. One bid by Jeff Spiller for \$2,000.00 and one bid by Ryan and Sarah Marlo for \$2,001.00. Jeff Spiller was asked if he wanted to increase his bid and he declined. Gale Burzynski made a motion then to accept the bid from Ryan and Sarah Marlow for \$2,001.00 Kelly Bate seconded the motion. Motion carried. All yeas. A third property, 309 W. Kelso St. did not receive any bids.

A packet of information was distributed about updating and revising the code of ordinances. After much discussion on the need to update old fines and bring the code up to date, Scott Dagner made a motion to do this at a cost of \$5,500 that can be billed over 2 years and Kelly Bate seconded the motion. It was decided for Scott to head up a committee to work on this including himself, Kelly Bate, Dave Kent and anyone else he wanted to ask.

Under new business, Mike brought up that the village owned 300 feet of roadway on Valier Lake Road but Browning Township was maintaining this. Steven Overturf, the Browning Township Road Commissioner, presented Ordinance 24-448 a jurisdictional transfer agreement of .09 miles of this roadway from the Village of Valier to the Browning Township. Motion was made by Kelly Bate to accept this agreement and seconded by Dave Kent. Motion carried. 5 ayes, 2 absent.


