AN ORDINANCE AMENDING CHAPTER 27 ("OFFENSES"), ARTICLE II ("GENERALLY"), BY ADDING SECTION 27-2-31 "VIDEO SURVEILLANCE AND ENFORCEMENT" OF THE REVISED CODE OF ORDINANCES OF THE VILLAGE OF VALIER, FRANKLIN COUNTY, ILLINOIS.

BE IT ORDAINED by the Board of Trustees of the Village of Valier, Franklin County and State of Illinois, as follows:

SECTION ONE: The Revised Code of Ordinances of the Village of Valier Chapter 27 ("Offenses"), Article II ("Generally"), is hereby amended by adding Section 27-2-31 ("Video Surveillance and Enforcement") to the Revised Code, which shall state the following:

27-2-31 <u>VIDEO SURVEILLANCE AND ENFORCEMENT.</u> Any individual entering the Village of Valier shall be subject to this Section, which states the following:

- (A) Any person entering the Village acknowledges, by use of the signage expressing such usage, that enforcement action of all motor vehicles and pedestrian violations will be enforced by means of electronic recording and video surveillance devices in conjunction with law enforcement.
- (B) Any person entering the Village will have impliedly given consent for the usage of their personal likeness and vehicle registration information for the purpose of prosecuting violations of the Revised Code of Ordinances of the Village of Valier and for violations of the Illinois Compiled Statutes.
- (C) Electronic detection devices and video surveillance equipment will be used in conjunction with law enforcement to gather images and video of violations of the Revised Code of Ordinances of the Village of Valier and violations of the Illinois Compiled Statutes.
- (D) Law enforcement personnel will have to complete enforcement documents within thirty (30) days of the incident.
- (E) It shall be the duty of a duly sworn law enforcement officer to gather relevant information to secure the prosecution of violations.

SECTION TWO: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed so far as such conflict exists.

SECTION THREE: This Ordinance shall be effective from and after its due passage, approval, and publication as required by law.

SECTION FOUR: The Village Clerk is directed to publish this Ordinance in pamphlet form.
