



## NOMINATION PAPERS

This document MN-S 403 contains the official Nomination Papers to be completed by individuals seeking to be Candidates in the 2025 Metis Nation – Saskatchewan Election.

**Nominations Open: 9:00 am on April 19<sup>th</sup>, 2025**

**Nominations Close: 2:00 pm on April 24<sup>th</sup>, 2025**

Nomination Papers will be accepted by the Chief Electoral Officer, or delegated Regional Returning Officer if:

- You are an eligible Candidate.
- You are nominated for just one elected office.
- You are nominated by a minimum of five (5) eligible voters (Regional Candidates must have Regional Nominators).
- Your Nomination Papers are correctly completed and filed before Nominations close.
- Your CPIC criminal record check is submitted valid within six (6) months.
- Your Nomination Papers are filed before nominations close.
- You have paid the \$100.00 deposit by certified cheque or money order.

Once the Chief Electoral Officer approves your nomination papers, you will receive a certificate indicating you are a qualified Candidate. Your filed nomination papers become public and may be viewed.

Only after approval, you will be listed as a Candidate on [www.mnselections.ca](http://www.mnselections.ca). You are also able to follow Municipal and Regional signage regulations and may also complete an optional Candidate Profile for [www.mnselections.ca](http://www.mnselections.ca).

### **IMPORTANT:**

- ***If you are nominated as a Candidate for more than one office, all nominations are VOID.***
- ***If you do not fill out your Nomination Papers properly, you can correct or replace them before nominations close.***

- I am not a judge of any court, other than a citizenship court.
- I am not an Election Officer or member of the staff of the Office of the Chief Electoral Officer.
- I am not confined to a penal or correctional institution or serving a sentence of confinement that extends to at least Election Day.
- I have not committed an offence in relation to elections within the previous ten (10) years.
- I have not committed an indictable offence within the previous five (5) years.
