Nominations Open: 9:00 am on April 23rd, 2026

Nominations Close: 4:00 pm on April 27th, 2026

Nomination Papers will be accepted by the Chief Electoral Officer, or delegated Electoral Officer if:

- You are an eligible Candidate.
- You are nominated for just one elected office.
- You are nominated by a minimum of two (2) eligible voters
- Your Nomination Papers are correctly completed and filed before Nominations close.

Once the Chief Electoral Officer approves your nomination papers, you will receive a confirmation email. Your filed nomination papers become public and may be viewed.

IMPORTANT:

- ***If you are nominated as a Candidate for more than one office, all nominations are VOID.***
- ***If you do not fill out your Nomination Papers properly, you can correct or replace them before nominations close.***

I, the undersigned, solemnly swear / affirm that I am eligible to be a Candidate for the Local Election, with the Métis Nation – Saskatchewan in the election held to be held **Local 71 – Pierceland April 30th, 2026** in Saskatchewan, and in particular, that:

- I am or will be 16 years of age or older, as of **April 30th, 2026**.
- I am and will have been a resident of Saskatchewan for at least six (6) months prior to Election Day
- I am ordinarily a resident in Region: Western Region1
- I am a registered Métis citizen under the Citizenship Act
- I am a member of the Local 71 - Pierceland
- I consent to be a Candidate

I further solemnly swear / affirm that I am not disqualified to be a Candidate and that in particular:

- I do not hold elected office pursuant to The Elections Act, 1996 (Saskatchewan); The Local Government Election Act (Saskatchewan), the Canada Elections Act, or a member of the Senate.
- I am not a judge of any court, other than a citizenship court.
- I am not an Election Officer or member of the staff of the Office of the Chief Electoral Officer.
- I am not confined to a penal or correctional institution or serving a sentence of confinement that extends to at least Election Day.
- I have not committed an offence in relation to elections within the previous ten (10) years.
- I have not committed an indictable offence within the previous five (5) years.
