Nominations Open: 9:00 am on February 16th, 2026

Nominations Close: 4:00 pm on February 27th, 2026

Nomination Papers will be accepted by the Chief Electoral Officer, or delegated Electoral Officer if:

- You are an eligible Candidate.
- You are nominated for just one elected office.
- You are nominated by a minimum of three (3) eligible voters
- Your Nomination Papers are correctly completed and filed before Nominations close.
- Nomination Papers must be accompanied by a copy of a Canadian Police Information Centre (CPIC) criminal record check document proving that you have:
 - Not committed an offence in relation to elections within the previous ten (10) years.
 - Not committed an indictable offence within the previous five (5) years.
 - Your CPIC must be dated within the last six months, prior to nomination closure.

Once the Chief Electoral Officer approves your nomination papers, you will receive a confirmation email. Your filed nomination papers become public and may be viewed.

Only after approval, you will be listed as a Candidate on www.mnselections.ca.

IMPORTANT:

- ***If you are nominated as a Candidate for more than one office, all nominations are VOID.***
- ***If you do not fill out your Nomination Papers properly, you can correct or replace them before nominations close.***

I further solemnly swear / affirm that I am not disqualified to be a Candidate and that in particular:

- I do not hold elected office pursuant to The Elections Act, 1996 (Saskatchewan); The Local Government Election Act (Saskatchewan), the Canada Elections Act, or a member of the Senate.
- I am not a judge of any court, other than a citizenship court.
- I am not an Election Officer or member of the staff of the Office of the Chief Electoral Officer.
- I am not confined to a penal or correctional institution or serving a sentence of confinement that extends to at least Election Day.
- I have not committed an offence in relation to elections within the previous ten (10) years.
- I have not committed an indictable offence within the previous five (5) years.
