



Chief Electoral Officer's Final Report
Election 2025

Forward

The 2025 Métis Nation - Saskatchewan's General Election was held on May 24, 2025. This was my third election, having served as the Chief Electoral Officer in 2021 and the assistant Chief Electoral Officer in 2017.

On June 5, 2024 I received a letter from Richard Quintal, Clerk of the Métis Nation Legislative Assembly (MNLA), directing me to prepare to hold the election on May 24, 2025. Having identified the date in 2024 allowed me to start identifying key office staff and polling locations early, which was beneficial since we had a Federal Minority Government and an early Federal Election could be called at any time. In various locations such as Cumberland House, Buffalo Narrows and Beauval there are few facilities suitable for poll locations and office space. Having the date identified early allowed us to secure office and poll locations for the Métis Nation – Saskatchewan's (MN-S) election. Fortunately, we were able to secure the nearly 100 polling stations required for the advance, mobile and election day polls.

Despite having Duty to Consult meetings after the 2021 General Election regarding boundaries, Elections Act Legislative Amendments, and proposed Constitutional Changes, none of the proposed Election Act recommendations were passed.

The MNLA was held in November 2024, however we were unable to reach the Election 2025 Agenda items. The agenda items contained recommendations to improve the Elections Act, appoint a complaints officer and adjudicator. A special MNLA was held in January and April to set the official election day, and to appoint a complaints officer and adjudicator. Unfortunately, we were not able to appoint an adjudicator for this election.

The Field Leadership Team:

The Chief Electoral Officer was supported by Rhea Moat, Deputy Chief Electoral Officer, who held this position in the 2021 General Election and was a Returning Officer in 2017. The Chief Electoral Office had to recruit and train all new Head Office staff as previous workers were unable to return. Several Regional Returning Officers (RROs) and Assistant Regional Returning Officers (ARROs) who worked in the 2021 election (and a few who worked in the 2017 Election) returned. We hired and trained 12 RROs and 12 ARROs to work and 4 CEO office staff members.

We tried to ensure that there was an experienced election officer to work in each region and carefully screened them to ensure we had fair, non-partisan election officials in place, in every region.

The RROs and ARROs along with the CEO's head office staff were trained in Saskatoon on April 4-6 2025.

Training focused on the following areas:

- Legislation
- The election calendar and key dates
- Computer set-up, election software and programs
- How to accept nomination packages
- How to recruit, train and facilitate an election in the Region
- How to handle voting, voting requirements, voter ID and voting opportunities
- How to handle special circumstances.

Election Resources

All election materials such as manuals and forms were prepared by the CEO and her team. Since there were few changes from the 2021 election, many of the materials were updated and revised for this election.

An online voter information system was developed for the 2025 Election. This was a custom software application designed to upload voter information, such as the voter's name, date of birth, citizenship number and address. This allowed the election staff to determine if people were eligible to vote, what region they resided in or if any of their information needed to be updated to reflect address changes. Additionally, this served as a tool that allowed us to see who voted in what region, on what day.

We were then able to export a list of Citizens who had voted to the Candidates who had requested the Second List of Names.

More resources were provided to Prince Albert, Saskatoon and Regina in terms of computers, equipment and staffing. Additional office staff were provided to several offices who had

anticipated higher voter turn out and needed dedicated officials to handle in-office voting, advance polls, mobile polls and to accommodate additional training sessions.

Election Readiness:

Returning Offices and the polling locations were secured prior to the election period. Many of the locations were secured between Oct. 2024 to Feb. 2025 after the provincial and municipal elections were completed in the Fall of 2024. Because the federal government was a minority situation and we knew that a federal election could be called at any time, we had to be very proactive in our approach to election preparedness.

We found it incredibly challenging to secure RRO Office space that would allow for short term lease agreements. Saskatoon and Yorkton were particularly challenging, and real-estate prices were proving to be higher in many areas due to landlords not wanting to rent short term. In the end, we put the Chief Electoral Office and the WR2A office within one larger space, which worked out well.

Cumberland House for example, has only has one location where we could set up the Returning Office and host the voting activities which was the Veterans Hall. We secured the Veterans Hall to ensure we would have access and meet all the requirements of the Elections Act. Additionally, when the Federal Election was called and overlapped with the Métis Election, Elections Canada requested we share the space with them in Cumberland House to allow people to vote federally. We were happy to cooperate with Elections Canada. Locations such as LaRonge, Beauval and Buffalo Narrows each had only one location to use as an office, therefore these locations were secured as soon as reasonably possible.

In Prince Albert, we were fortunate to secure the Prince Albert Exhibition. This location allowed for a greater number of voters to access the in-office voting requirements of the Act, but also allowed the Returning Office to over see the advance polls and election day polls in one central location. The board room was also utilized as a training space.

Declaration of Election

The Declaration of the Election was on April 19, 2025 at 9:00am. This signals the start of the thirty-five day election period. The Declaration provides the voting opportunities and signifies that the CEO Office and the Regional Returning Offices are open to the public and that nomination papers can be filed. (See Appendix 2)

The Nomination Period

The nomination forms were updated and posted to the MN-S website on April 1, 2025. The Declaration of the Election was on April 19, 2025, and nominations could be submitted to the CEO or the RROs from April 19 to April 24.

This election saw a total number of 50 candidates submit their nomination papers, with one withdrawing to support another candidate. Northern Region 1 had only one candidate nominated who was acclaimed to the position of Regional Representative.

Candidate Profiles

Voter feedback is always welcomed and reflected on and in 2017 and 2021 voters frequently indicated they didn't know who the candidates were. In the 2021 Youth President Election we were able to pilot on-line Voting. This allowed us to experiment on a smaller scale and test technology in a new way. In the 2021 Youth Election we posted on-line profiles to better inform voters about the individuals who were seeking their vote. This worked extremely well and we were pleased with the results and feedback, and felt it was a positive and modern step forward that we incorporated for the general Election.



Candidates were all encouraged to upload a standard passport like photo, contact information and why they were seeking election. This was displayed on the Candidate Page as nominations were received. If a candidate did not want to complete the profile information, then their name, and the position they were seeking in the election, were displayed only.

We received a lot of positive feedback from the voters on this and it appeared to be well received beyond our expectations. For example, *Missinipi Broadcasting Corporation* published an article on April 25, which directly linked the MN-S Election website, candidate profiles and the Regions in which people were seeking nomination in. *Battlefords Now* also linked the online president and vice president forum link into their May 2, 2025 news article.

On May 5, 2025 the MN-S Newsletter was published with Election information and links to our website. On May 5, we had a spike of nearly 600 users go to the website to review candidate information.

Candidate Forum

Candidates for executive offices were offered an opportunity to tell voters about themselves and why they were running for President, Vice President, Secretary and Treasurer through an all-candidates forum. We offered pre-recorded sessions that candidates could sign up for in pre-determined time slots. Candidates were provided a list of standardized questions that they each could respond to.

As in the 2021 Election, the CEO's office facilitated the all-candidates Forum. In 2021 we were dealing with a pandemic and John Lagimodie of Eagle Feather News was used as the moderator. He received the name and contact information for the forum through the CEO's Office.

This time, the CEO's office conducted the Candidates Forum by having an online link for Executive Candidates to sign up for an interview session and the standardized list of questions were provided to the Candidates in advance. Our moderator was a local president- Brett Angus- and the interviews were pre-recorded. On May 1, the President and Vice President interviews were released with approximately 120 unique viewers tuning in live. The second set of interviews with the Secretary and Treasurer candidates were released on May 2. All of the videos stayed on the MN-S Election website for the remainder of the election period for voters to review when it was convenient for them. Candidate participation was optional and some candidates decided not to take part in the forums.

The Chief Electoral Office also had candidate signage made and candidates who wished to have their picture taken against the Electoral Sign were allowed to do so. This seemed to be well received with the majority of the Candidates taking pictures against the backdrop and posting it to social media, along with their certificate that they were an accepted candidate in the 2025 Provincial Métis Election.


During the MN-S Election we note the following statistics from our website:

- We had 18,000 active users on the website, with most people using their cell phone
- We had over 500 unique hits on the Nomination Profiles
- 350 users during the candidate forums
- Our website saw 2.8K active users
- We had nearly 600 people access the MN-S Election website on May 5 after the MN-S Newsletter was released.

Candidate List of Voters

The Saskatchewan Métis Election Act 2007 S. 50.2(C) requires the CEO to provide a list of names of all those who have voted at the Regional Returning Office, advance polls and mobile polls. Each candidate who wanted a list of names of those who voted had to sign a declaration form stating that they would not misuse the list, and would not use the list for any purpose other than for the General Election.

As we saw in the 2021 General Election, citizens had strong feelings about the voters list and list of those who voted. Many candidates wanted a complete list of citizens and where they reside and again wanted a complete list of who voted in the election. Providing a full list of citizens or a complete voters list is not permitted within the current legislation.

Maps:

The same maps and boundaries that were utilized in the 2021 Election were used in 2025. After the 2021 election, consultation meetings were held, with detailed maps proposed to help clarify the boundaries in an attempt to ratify them. The proposed changes did not go through and were not ratified. During the 2025 Election, there were very few inquiries as to where the boundaries were and where people should be voting.

The MN-S Website displays the maps year-round, along with a list of cities and towns and which region they belong to. We provided the link to candidates for their campaign purposes as requested and provided hard copies of the list to our election officials so that they knew if voters were in the right region when they went to vote in case there were questions or concerns.

Voter Eligibility and Citizenship

The MN-S Registry Office oversees all of the Citizenship Registration, and ensures that each person meets the criteria for Citizenship. The Office provides the CEO with the updated list of Citizens who are eligible to vote.

The Registry Office checked the list of eligible citizens twice during the election against the Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) list. They did an initial check prior to providing the list to the CEO, again after the nomination period, and right before we started in-office voting. We manually removed ineligible voters who were identified as taking First Nation Status, so that they would not be permitted to vote. No one who was identified on the CIRNAC list ran as a candidate or voted in the election.

The Registry Office is run by Deb Donaldson, Registry Director, and her dedicated assistant for election purposes was Leah Hansen. Both of these individuals were instrumental in ensuring they were available to answer questions or concerns and ensured that the Registry Office was staffed and able to respond to citizen inquiries.

Ms. Donaldson was invited to come to the CEO's Field Leadership Training Session in April and provided an overview training session to the election staff on how a Métis person gets citizenship, including the processes used and provided sample citizenship cards to the staff for training purposes.

When the Métis citizens came to vote at a polling station they had to provide

- Approved identification that included their name and address which corresponded to the region they were voting in
- Their Métis Citizenship Card or confirmation of citizenship from the Registrar
- A valid Saskatchewan Health Card as identified in the legislation as a requirement.

Each voter then had to sign a voters registration form and declaration confirming they were eligible to vote and confirm they were a Métis citizen.

Voting Opportunities

Métis citizens had the following voting opportunities:

- May 9-16 Early Voting in the Regional Returning Offices
- May 17 Advance and Mobile Polls, including Correctional facilities
- May 24 Election Day

Polling locations were established based on population distribution within the region. Consideration was given to reasonable driving time, and proximity to local services. If polling locations were not well utilized or had low voter turn out in the 2021 Election, different polling locations were established where possible. Additionally, the Advance Polls and Mobile Polls were held on the Saturday of the long weekend. Several communities such as Hudson Bay would like to have seen an Election Day poll instead of an advance poll because of the dates and timing, which has been noted by the Chief Electoral Officer.

Every Region had its own Regional Returning Office as required in S. 44 of the *Saskatchewan Métis Elections Act 2007*, along with at least one advance polls. In total we had 38 advance polling locations, some with multiple polling stations within the building. For example, Prince Albert had one polling location with 3 stations inside of it. Regina, had two polling locations with up to three stations in each. The advance Poll voter turn out in the province was not as strong as anticipated, with only 882 people voting on May 17, 2025.

Mobile polls were established in areas where there wasn't sufficient population to hold a full day poll, while still providing an opportunity for eligible voters to vote. In total there were 5 mobile polls established.

On Election Day, there were 41 polling locations established throughout Saskatchewan. Again, sometimes there were multiple stations inside of one location.

To inform voters about the voting opportunities the following activities were conducted:

- The MN-S Election website was updated with the most current information and displayed information that was pertinent on the home page and transitioned the information as we went through the calendar of events;
- We published contact information for the CEO Office and Regional Returning Offices, through the website;
- Election communications and updates were sent out through the MN-S Newsletter and dedicated Facebook pages. (MN-S Election Facebook page and Métis Nation Saskatchewan's Facebook page);
- Social media platforms were utilized such as YouTube and Snapchat; and
- Advertisements were placed on billboards, newspapers, radio stations and several interviews were conducted by the CEO with the media.

In an effort to create awareness of who the candidates were, candidate signs were made for candidates to pose against and have their picture taken and floated to their social media platforms. I voted signs were also made for voters to take selfies with and share with their friends and family on social media.

Election Results

All of the ballots cast during the election were counted on Election night. The Election Officials called in to their Regional Returning Office and/or CEO Office and the data was entered into a centralized computer results system. After a preliminary check the data was posted to a live feed onto the MN-S Election Website.

We used count teams in many of the areas to facilitate the counting of the ballots which was necessary because of the large number of ballots cast in some regions. Candidates' representatives were allowed into the polling locations to witness the counting of the ballots and were provided with a copy of the statement of the vote upon request. All ballot boxes and supplies were accounted for. The lists of voters were reviewed to ensure only Métis Citizens were eligible to vote.

There were recounts by the Court of King's Bench, for three elected offices - Vice President, Treasurer and Regional Representative for Eastern Region 2. Announcement of the Official results for these three offices were delayed until the recounts were completed. The Eastern Region 2 candidates were separated by a total of 2 votes.

Recounts

The CEO applied for the recounts as required by the *Elections Act*. The recounts took significant resources and time. The recount for Eastern Region 2 took place on Sept. 5, 2025 while the Vice President and Treasurer recounts took place on Sept. 16 & 17, 2025.

A recount proposal was provided to the Judge to recommend an efficient procedure for proceeding with the recount. The Judge and Candidates agreed to the recount proposal submitted by the CEO. The CEO and DCEO counted the ballots in front of the candidates and Judge for the position of Eastern Region 2. The results of the Chief Electoral Office were upheld and candidate Brent Digness was declared the Official Candidate. No ballots changed during this recount.

For the Vice President and Treasurer Offices, the CEO assembled five two-person count teams. The candidates were allowed to be present along with their candidate representatives. One candidate or their representative was allowed per count team. The unofficial results declaring Michelle LeClair to be Vice President and Jeremy Denomie for Treasurer were also upheld, with minimal changes to the final count.



Complaints and Adjudication

The *Saskatchewan Métis Election Act 2007* requires the appointment of a Complaints Officer and an Adjudicator. Mr. Lorne Gibson was appointed as the Complaints Officer, but no Adjudicator was appointed for the 2025 General Election.

The Chief Electoral Office is often the first one to receive an inquiry or complaint regarding a suspected election infraction. The Chief Electoral Office spends a great deal of time trying to educate people on what is a valid complaint or infraction to the Elections Act. Several complaints came to the Chief Electoral Office, and while we informed several people their complaint was not a violation of the Elections Act, the complaint would nevertheless be forwarded to the Complaints Officer.

An informal arrangement has been in place between the Complaints Officer and the Chief Electoral Officer to handle complaints in this way as per section 123 of the *Act*. It minimizes the costs to Métis Nation Saskatchewan if there are hundreds of complaints that do not contravene the Election Act. Additionally, by being available to answer questions or concerns the Chief

Electoral Officer can identify potential concerns early on and as required in section 124 of the *Act*, notify individuals of potential offenses or infractions.

The complaints officer did a very thorough job investigating and responding to complaints during the 2025 General Election. Mr. Gibson has a wealth of election experience and served on the Manitoba Law Society as Complaints Review Commissioner. His knowledge of election best practices and being able to apply his professional experience to the Métis Election was invaluable. He was able to gather information, and determine rather quickly if there was an offense or not. He spent extra time investigating and providing a written response due to the fact that there was no Adjudicator. He wanted to ensure that when he responded the complainant understood his response and his conclusion. Mr. Gibson responded to a total of 25 complaints. None of the complaints would need to have been sent to an Adjudicator had one been appointed this election.

Many of the incumbents who wanted to seek re-election were reluctant to start advertising their bid for re-election, while those who did not hold elected office started campaigning as early as Jan. 2025. We found the election campaign period and the complaints that came to the CEO office started much earlier and our response to the public was greater than it had been in the past. We started receiving questions, concerns and complaints about campaigning in January of 2025, before our CEO office had dedicated staff members set up to handle public inquiries and complaints.

In an effort to reduce outside complaints from municipal officials, additional information was provided by the CEO office about campaign material on municipal property in several areas in an effort to reduce the significant complaints the CEO office had in the past. The CEO office informed the cities of Saskatoon, Yorkton, Regina and Prince Albert about the upcoming Election and proactively provided a guideline to candidates about campaign material posted in these cities. The CEO office did not receive complaints about signage in and around the cities and other municipalities this election.

Election Costs

The MN-S provided the funding for the MN-S Election, and the CEO has the authority to purchase and enter into leases as required and permitted by the *Saskatchewan Métis Elections Act 2007*. The MN-S accounting staff ensured timely payment of expenses for the election.

Election costs are primarily driven by the number of polling locations, staff required and material distribution. The CEO tried to find furnished office spaces where available, and purchased or rented equipment where reasonably necessary.

Some offices came with Internet connections provided, other offices were run off of hotspots, while the CEO Office and WR2A office had to have a dedicated Internet connection brought in.

Elections Saskatchewan provided a loan of cell phones which were returned following the election.

A schedule of fees was established for election officers and their rates of pay mirrored the tariff of fees used by Elections Saskatchewan.

A preliminary budget for the overall election was established by the Chief Electoral Office.

Recommendations to Amend the Saskatchewan Métis Election Act 2007

Many of the same recommendations will be made after this election as there were no legislative changes from the 2021 Election to present.

- 1) **Establishing an Election date:** Section 28 (1) in the Elections Act should be amended to include a date or timeframe for holding general elections, such as the third Saturday in May every 4 years. This would provide greater predictability as to when elections would be held and allow the Chief Electoral Officer to identify polling locations and Regional Returning Offices in advance of the election. It also allows voters, candidates and stakeholders an identified time frame for the election and allows people to set time aside to run as a candidate or clearly identifies black out periods when the PMC will not be sitting.
- 2) **Registering to Vote** – S.12 of the Saskatchewan Métis Elections Act 2007 outlines the right to register to vote. In S. 33.2 it requires a registration station. Currently MN-S has a central Registry Office and keeps careful records of who their citizens are and who is eligible to vote. The list of those eligible to vote are provided to the CEO by the Registry Officer. The requirement for people to register at the poll is no longer necessary and should be eliminated.
 - Eliminating voter registration at the poll will also eliminate the need for Registration Officer positions at the poll.
- 3) **Registering to Vote -S 12.2 (e)** of the Saskatchewan Métis Election Act 2007, requires that in order to register to vote the voter must present their current Saskatchewan Health Card. Requiring people to show their Health Card should be eliminated from the Saskatchewan Métis Elections Act 2007 as it is already a requirement of Citizenship. Requiring people to provide their Health Card creates a barrier to voters and is an unreasonable requirement.
- 4) **Voter Registry -S. 13** requires that the CEO shall ensure the preparation of a voter's registry with information from the direct registration of voters from time to time. The CEO is currently not involved in registering Métis citizens as this is done through the Registry Office, therefore these requirements should be eliminated.
- 5) **Voter Registry Section 12- and Cell phone use -S. 129** should allow the use of cell phones to display identification at the polls such as a utility bill displaying a person's name and address, or to take a picture of the final statement of the poll for candidates on election night but prohibit people from taking pictures, videoing or using cell phones for any other purpose inside a polling station.

- 6) **General Election S. 29** – The Métis Nation – Saskatchewan may want to re-evaluate the practice of appointing interim executive members and regional representatives and instead provide for the election of new members through a by-election to be conducted by electronic voting. It is very costly to run a provincial election for an executive member, however with electronic voting it would allow democracy to be served and provide a cost-effective method of voting.
- 7) **Protection of Voter Information – S. 50 (2)**- We have minors, and vulnerable people and people who want their information protected who are voting in Métis elections. Consideration needs to be given whether this section of the Act is required as currently providing the information for S. 50.2 is generally not that helpful.
- Additionally, consequences or sanctions need to be identified for the misuse of the voters list.
- 8) **Campaign material, Section 127(3)(a)** in or on any premises used as a polling station, should be evaluated. Currently it makes it an offense for any person to display or place campaign material in or on any premises used as a polling station.
- Typically, the Chief Electoral Officer uses the rule of thumb for candidate posters and campaign material to be more than 50 feet from a polling place or the entrance of the building in which a polling place is situated which is consistent with Elections Saskatchewan's legislation.
 - Clarifying the rules around campaign signage should be considered.
- 9) **Criteria for a recount – Section 79** sets out the criteria for an application to be made by the CEO for a (automatic) recount. If the difference between the number of votes in favour of the candidate who received the most votes and any other candidate for the same office is nil or less than 2% of the total number of votes cast for the office, the Chief Electoral Officer shall, without delay, apply to the court for a recount.
- This threshold is set too high and leads to the conduct of unnecessary recounts in which the outcome is highly unlikely to change.
In this election we had 3 recounts; the Vice-President, Treasurer and Eastern Region 2 representatives.
 - The Eastern Region 2 Candidates was separated by 2 votes, while the Vice President candidates were separated by 82 votes and the Treasurer candidates by 43 votes. In the 2025 Election the automatic threshold for a recount was 103 ballots or less. Therefore, both the Vice President and Treasurer positions had to have a recount. The threshold should be lowered to 1%.
 - The less populated Regions, such as ER1 only had 71 voters. In this case, the recount trigger would be one vote. A two vote difference would not qualify for an automatic recount. This means that the criteria for a recount involving regional candidates is too low. The criteria for an automatic recount should be set as an absolute number of votes such as 5.

- Neither of these changes would limit a voter's existing right to apply to the court for a recount on the grounds that an election officer:
 - improperly rejected ballots,
 - made an incorrect statement of the number of votes cast for any candidate or
 - improperly counted or added up the votes.
- 10) **Candidates Forum** - In each election since 2017, the CEO's office has fielded questions about who are the candidates running in the election, and wanting to know about candidate platforms. Section 93 (2)(g) of the Act allows the CEO to provide public education and information programs intended to make the electoral process better known to the public. We did have a couple of candidates lodge complaints against the CEO regarding this. If MN-S would like the CEO to continue candidates' forums, it is recommended that a provision be extended in the Act to clearly outline this.
- 11) **RRO and ARRO acting as Deputy Returning Officers and Poll Clerks – Section 110(3)** of the Act should be repealed as a cost savings measure for offices that do not have the volume of voters warranted to have additional staff.
- 12) **Campaign Contributions and Expenses** are addressed in sections 89 and 90 of the Act. There are few guidelines around campaign contributions or election expenses. Citizens are looking for more transparency on campaign expenses and who has made a contribution to a candidate. A generalized fillable form could be provided to candidates to report on campaign expenses and contributions received.
- One inquiry was received from the Affinity Credit Union from an individual who held the title of Compliance Lead Regulatory who wanted additional information and guidance around publicly funded campaigns. General information was provided to them which is outlined in the Act, and it was confirmed that a candidate was trying to set up a special account for the purpose of the election.
 - Candidates did set up online platforms and websites which had special links imbedded in their websites for contributions to be made to the candidate.
- 13) **Section 38 -Form of Ballot** - we may want to remove the level of detail connected to the ballot requirements, specifically to remove the counter foil and stub being numbered. The ballots are hard to remove from the books and takes a lot of time. Currently it takes a lot of time to print, the ballots, and they are more costly. It takes additional time to issue and deposit into the ballot box. We have several control features on our ballots that would make it unlikely they could be reproduced and each DRO is required to initial their own ballot. We could have the stub printed with an initial control number and the ballot paper detached and issued to the voter. We currently issue up to 5 ballots per voter which is quite a big process.

Recommended Changes to the Election Process

- 1) Clear guidelines and procedures surrounding the regional offices during the writ period and what staff can do during that time period should be evaluated. As the CEO office is independent, we are not aware of all the functions or who is employed at the Regional Offices and who they report to during the election period. We had several complaints of Regional Office staff trying to establish forums for the candidates in their region, posting information about the election and/or participating in various activities. Some regional offices were wondering about operational functions during the election period and what can and can not be done. General information and clarity should be provided.
- 2) A general outline of the roles and responsibilities of each office should be provided by MN-S that is accessible to the public to review. We had a wide range of questions on what does the Regional Representative do, or what are the Secretaries duties, how much of a time commitment is this, how often do the PMC members meet, what is the remuneration for the position. Some Citizens were very new and asking additional questions, but a comprehensive overview of the elected person's responsibilities, time commitments, and duties would be appreciated by potential candidates.
- 3) The CEO office started receiving questions, concerns and election related questions in January of 2025, before our CEO office had dedicated staff members set up to handle public inquiries and complaints. We may need to budget for part time election staff earlier if we continue to receive questions and concerns and expect additional time and resources from the CEO's office.
- 4) A candidates information night could be implemented to help candidates understand the nomination period, how to submit a nomination package, receive an overview of the election calendar, what a candidate's representative is for and provide information on the Elections Act. If we have an election date, and legislative changes completed earlier, the CEO office can hold an information night for potential candidates to help them gain an understanding of the election.

WHEREAS the Métis Nation – Saskatchewan is committed to an open, transparent and democratic process for the election of the Provincial Métis Council;

WHEREAS the Métis Nation – Saskatchewan, at its Legislative Assembly held on February 20, 2021, approved and appointed me as the Chief Electoral Officer for the Métis Nation – Saskatchewan;

NOW THEREFORE, I hereby declare, pursuant to the Saskatchewan Métis Election Act 2007 and every enabling power, that:

1. A general election shall be held in Saskatchewan for Métis Citizens of the Métis Nation of Saskatchewan;
2. Election day shall be the **24th day of May 2025**;
3. The day of the advance vote is the **17th day of May 2025**;
4. Nominations open at **9:00 a.m.** on the **19th of April** and close at **2:00 p.m.** on the **24th April 2025**;
5. The election shall be conducted fairly and impartially in accordance to the Saskatchewan Métis Election Act 2007.
