1. Overview

INFINITE COIN USD (INF_USDT) is an ERC 20 utility token designed for a mobile first wallet experience and transparent treasury operations. The project emphasizes real vield economics: no new token inflation is used to pay rewards. Instead, a portion of net product revenue can be routed to a staking vault and/or liquidity operations.

2. Utility & Economics

Utility: INF_USDT unlocks wallet fee discounts, premium features, and eligibility to participate in the real**=**yield staking vault.

Real■Yield Staking: Net revenue generated by the platform (e.g., swap/on ramp fees) may be deposited into a dedicated vault and distributed pro∎rata to stakers in stable assets (e.g., USDT). This mechanism avoids inflationary emissions.

Liquidity: Treasury deploys concentrated liquidity to PancakeSwap v3/Uniswap■style pools to maintain healthy market depth and low slippage for users.

3. Token Policy & Governance

Key controls (if any) are held via a multi signature wallet and, where practicable, guarded by a timelock. Major changes (e.g., treasury allocations, vault parameters) are announced publicly with transaction proofs provided through the block explorer. The project avoids any promise of guaranteed returns; distributions are discretionary and depend on realized net revenue.
