## **IRS TAX TIPS**

### Form W4 - Employee's Withholding Certificate

Q: Why redesign the W4 form?

A: The new design reduces the form's complexity and increases the transparency and accuracy of the withholding system. While it uses the same underlying information as the old design, it replaces complicated worksheets with more straightforward questions that make accurate withholding easier for employees.

Q: My tax situation is simple. Do I have to complete all 5 steps on the form?

A: No. The form is divided into 5 steps. The only two steps required for all employees are Step 1, where you enter personal information like your name and filing status, and Step 5, where you sign the form. Complete Steps 2 - 4 only if they apply to you. Doing so will make your withholding more accurately match your liability.

Q: What happens if I only fill out Step 1 and sign the form?

A: Your withholding will be computed based on your filing status's standard deduction and tax rates, with no other adjustments.

Q: When should I increase my withholdings?

A: You should generally increase your withholding if:

- you hold more than one job at a time or you and your spouse both have jobs (Step 2)
  or
- you have income from sources other than jobs or self-employment that is not subject to withholding (Step 4(a)).

If you do not make adjustments to your withholding for these situations, you will very likely owe additional tax when filing your tax return, and you may owe penalties. For income from sources other than jobs, you can pay estimated tax instead of having extra withholding.

Q: When should I decrease my withholdings?

A: You should generally decrease your withholding if:

- you are eligible for income tax credits such as the child tax credit or credit for other dependents (Step 3), and/or
- you are eligible for deductions other than the basic standard deduction, such as itemized deductions, the deduction for IRA contributions, or the deduction for student loan interest (Step 4(b)).

### Ingredients:

- 410g can sliced peaches in syrup
- 1 tbsp butter
- 150g raspberries
- 100ml whipping cream
- ½ tbsp icing (confectioner's) sugar
- 100g granola

#### Method:

- Pour the can of peaches, with the syrup, into a small saucepan over a medium heat. Add the butter and simmer until the peaches are hot. Once simmering, add the raspberries and cook for 1-2 mins more until hot.
- Meanwhile, put the cream in a large bowl with the icing sugar and whisk until lightly whipped.
- Using a slotted spoon, put the peach Melba mixture into four serving dishes and top each with a sprinkling of granola and a dollop of cream.
