Year-to-Year – A look back over 2019/2020

The last year, between annual meetings, has been very active for Timber Valley.

We implemented the Rental Restriction Amendment (RRA) which has proven successful in limiting the number of rental properties in Timber Valley.

After a long negotiating period, involving numerous officials from the City of Greenwood, in July 2020 we received clearance from the Board of Public Works and Safety for the Timber Valley rip-rap project. We are now at the stage of negotiating insurance requirements with the City of Greenwood and hope to complete these negotiations in the very near future.

We have repaired the fence which runs along 125W and are taking bids to paint the fence.


At the request of several homeowners, we are taking bids to extend the southern end of the Timber Valley path to the edge of Underwood Court.

The problem of geese has been largely resolved due to the board hiring the "Geese Police."

We implemented a new Architectural Control Committee policy where a neutral color scheme will be maintained throughout the neighborhood but with freedom and flexibility for homeowners to include accent colors.

We have maintained a sound financial condition by carefully considering where to spend money, looking for ways to save money, and tracking spending.

Potential Projects for 2021

As we look ahead to next year, there are improvements which can be made.

However, the board would like your feedback because we are elected to represent all homeowners. The following are ideas which have been raised in the past and that the board is considering for 2021.

Front Entrance – The main front entrance (including the sign) could be upgraded. The landscaping around the front entrance could be expanded and improved upon as well as building a new frame for the current Timber Valley sign.

Landscaping – There are many gaps on the tree line along 125W. The board is considering filling those gaps with trees and bushes to match what we already have in place.

Landscaping (Part 2) – With the anticipated completion of the rip-rap project, the board plans to consider what additional landscaping (if any) could be completed around the ponds. We are very mindful to actively consider all opinions on this subject. In particular, we want to hear from homeowners who live on the ponds.
