#### **RULES & REGULATIONS:**

- In accordance with SOBHD rules, the Judge's decision is final. No access to Judge's sheets will be allowed. In the event of a protest, a \$25.00 non-refundable fee must accompany a written complaint and be submitted to the organizers the same day of the competition and no later than 12 midnight.
- The Greater Moncton Scottish Association will not be responsible for lost articles, accidents, injuries
  or illness to competitors or spectators at the competition.
- All dancers must present a valid 2018 ScotDance card. Awards will be withheld and a penalty of \$5.00 charged without a current dance registration card.
- Competitors must be in full costume to receive award. <u>Dance shoes included</u>.

#### DANCER/PARENT WAIVER

I am aware that participating in the Moncton Highland Games Dance competition involves the potential for risks, dangers and hazards, including but not limited to:
