We, Booth Operator(s), hereby make an application to become a vendor at the Georgetown Sertoma 4th of July Celebration. We, as Booth Operator(s), agree to abide by the rules and regulations as set forth herein and such other rules as may be established or amended by the Sertoma Club of Georgetown and the City of Georgetown. Booth Operator(s) will only sell those items or conduct those activities that have been specifically approved in writing by the Sertoma Club of Georgetown. Furthermore, Booth Operator(s) hereby releases, forever discharges, and holds harmless the Sertoma Club of Georgetown, Inc. and the City of Georgetown, its officers, council members, directors, servants, agents, employees, and volunteers from any loss, lost profits, damage, or injury to the person or property of the Booth Operator(s), or Booth Operator(s) agent, customers, or invitees. It is further agreed that the Booth Operator(s) shall maintain their space, sales products, activities, and business practices in compliance with all applicable local, state, and federal laws and regulations. Booth Operator(s) understands that violation of or non-compliance with this release or any rule, regulation, law, ordinance, or decree may result in the immediate expulsion of Booth Operator(s), their agent(s), and their trailer or booth from the event without refund of their registration fee. In addition, I hereby give permission to the Sertoma Club of Georgetown to use my name and any pictures/videos taken of me during the event in any promotional materials, publications, or on the internet. We understand that the fee is non-refundable if the event is canceled due to inclement weather.

Georgetown's Annual 4th of July Festival is put on by the SERTOMA Club of Georgetown, TX, and we're thrilled you're interested in joining us!

Our goal is to make this a safe and happy 4th of July event for everyone. There are many volunteers working hard to make it a good day for you, and we appreciate your participation.

Just a reminder, it can get hot. Be sure to have cold fluids available at all times. You may also want to bring a battery-operated fan and/or electrolytes.

We would appreciate it if you could design your booth so that buyers are not in the heat, if possible.

Vendor Setup & Tear Down

Setup: 6:00am-9:00am on Friday July 4th, 2025

Check in with Sertoma volunteers at the main stage to receive booth location. Parking permit is **required**. Drive your vehicle to designated area, unload as quickly as possible, then move vehicle to parking area. Speed limit is 20 mph at all times anywhere in the park. Road to the vendor area is closed for entrance at 10:00 a.m.

Tear Down: 10:00pm After the Fireworks Show

No vehicles may move into the vendor area until after the fireworks show has ended (approximately 10pm). Shortly after the fireworks show, vendors will be allowed to drive to their booth area to load.

If you decide to leave prior to the end of the fireworks, you must carry all items to your parked vehicle.

Vending Hours & Requirements

Hours: 10:00am - 10:00pm Thursday, July 4, 2025

Vendors may sell until the completion of fireworks and after 10:00 p.m. if there are customers.

Note: Vendors can only operate out of their designated booth, no "walk-about" vending. Craft vendors are not allowed to sell or give away any type of beverage, fireworks or live animals.

Proof of Insurance (All Vendors)

Proof of Insurance must be provided to Sertoma Club of Georgetown along with your application and payment.

City of Georgetown Fire Code Compliance (All Vendors)

All vendors must comply with The City of Georgetown Fire Code regulations. Note: the city requires all tents or canopies shall have a minimum of **40 lbs on each leg tied through the frame of your tent.**

Health Department (Food Vendors)

The Williamson County Health Dept. requires all food vendors to obtain a temporary food permit. Go to www.wcchd.org to apply.
