Dear Windermere Oaks Community,

Three of our members recently visited the management company office to view proxies from this year's Annual Meeting. After viewing, they made copies for themselves and took them for their own personal record. We know of at least one instance where one of our members has been contacted by a member from this group about their choice to grant their proxy. That member let the Board know that they were not happy about their voter privacy being violated, and also reported to the board that the unsolicited caller proceeded to try and shame the member for granting their proxy, and convince them that they shouldn't be using a proxy to cast their vote.

Our by-laws and state law specifically allow for the use of proxies. This year, we elected to furnish members with an absentee ballot and provide proxy forms on request, to cast their vote. We did this to comply with our bylaws and state law, but also to allow everyone the greatest opportunity to vote their choice. Allowing the use of both forms improved transparency, and proxies help to assure a quorum.

We've consulted with our POA Attorney and confirmed the POA should keep proxies for the duration of the window after any vote in which members have the right to request a recount under state law. After that period, there is no duty to retain proxies, so they are purged in order to best protect privacy. State voter privacy laws protect ballots and absentee ballots from being provided to anyone, but proxy forms are not protected. If you used a proxy this year to vote your choice, and someone contacts you about your use of a proxy, please let our management company know, so we have a record of the unsolicited contact. You recently received a notice about proxies from CAM, our management company on behalf of the WOPOA board via email and U.S. mail. It contained many inaccuracies that need correction. Yes, three members went to our management company on February 20th to inspect the proxies from the 2018 annual meeting <u>as members are permitted by law.</u> During inspection of the proxies, a CAM employee asked if we wanted copies. She made them for us and charged us accordingly.

At our annual meeting Dana Martin was asked about her sending a mass email to members for their proxy with her name already filled in. Her response was that she "sent it to friends." So we set out to find the truth. Dick Dial called Mr. Elder of Elder Homes on February 9th. In our opinion Mr. Elder had enough proxies to seriously influence the outcome of the election—he owns 30+ lots. Mr. Elder was a wealth of knowledge. He told Dick that he did indeed give Ms. Martin his proxies to defeat the proposed increase to our road use fee. This fee is used to cover the cost of damage to our roads during new home construction. This fee has not increased in 20+ years. It is perplexing that Ms. Martin is the Road Committee Chairman, was in favor of the road use fee increase and was instrumental in adding this increase to the ballot. After promoting this increase, Ms. Martin used her proxies to defeat the issue. This defeat cost the subdivision \$35,000+ in lost revenue that would have been generated by this increase.

In summary, Ms. Martin used her proxies to cost Windermere Oaks a very large sum of money, Ms. Martin's actions caused the removal of Micki Bertino from the board and the installation of Joe Gimenez. Ms. Bertino was well-liked and worked hard for our community.

In closing, we are asking the board to hold a special meeting in June to abolish proxy voting. Mailed-in unsolicited absentee ballots would easily clean up this mess. WE THE PEOPLE have a say in who sits on our board and to once again vote for the road use fee that is vital to keeping our roads in good shape. Hello Windermere Oaks POA Members,

Some, possibly all, of our members received a letter from Dick Dial and others implying that the proposed increase of the road use fee has been defeated.

While in their opinion this is a fact, it is simply not the truth. Currently, the measure is unsettled because we have not yet received the required number of votes to make the change. Among those who have cast ballots, the measure is leading by roughly a 2-1 margin, which bodes well for future passage. For those members who have not voted, you will likely see more about this from WO POA in the near future.

With regards to Mr. Dial's assertion about roads committee chair Dana Martin, it is entirely up to the property owner and the person offering them their proxy as to how they vote. Mr. Elder's wishes, and the respect which Ms. Martin demonstrated him with her vote, may have been undesired in the view of Mr. Dial and the others, but there certainly is no requirement as to how any proxy has to vote given their position on committees, the Board, or any other organization.

The larger question of how Mr. Dial knew to contact Mr. Elder before he had received copies of the proxies from CAM's office is an issue which our Board may have to address in the future. It may be that a member who participated and or witnessed the vote-counting at the annual meeting shared that information with Mr. Dial, violating their privacy. We will have our attorney review this issue with Board.

Finally, Mr. Dial and his group also introduced a new website address to disclose copies of the proxies he sought from our management company. Please be aware that their site is not the official site for Windermere Oaks Property Owners Association. The community website is, .
