

ABOUT THE CLUB

Paul Bunyan is a private club belonging in its entirety to the membership in good standing. Membership is by application and approval of the existing general membership only.

Administration of the club is achieved through time volunteered by elected officers and directors who are governed by the club's constitution and by-laws.

All members are encouraged to participate in maintaining the club by volunteering time for a scheduled work party. Many give considerably more of their time by holding office, running matches or other activities.

JUNIOR CLUB

The junior club has an active group of young shooters ages 11 to 20 years. We compete in shooting matches around the state. Several of our shooters have gone on to win scholarships and compete at the collegiate level.

FACILITIES

Paul Bunyan Rifle & Sportsman's Club range has available to its members a:

RIFLE RANGE-With target placement positions from 25 to 200 yards for practice and up to 600 yards for matches. The range is lighted to 200 yards with a covered firing line.

PISTOL RANGE-With 25 and 50 yard target placement positions, night lighting, and a firing line enclosed on 3 sides for inclement weather.

SHOTGUN RANGE- Trap range with a hand operated mechanical clay thrower for individual practice and a more full-feature house for scheduled practices and matches. A patterning board is also available.

TO APPLY FOR MEMBERSHIP

Prospective members will be required to attend an orientation briefing, which are held on the second Sunday of each month at the clubhouse at 4PM by reservation only. Plan on arriving a few minutes early as the orientation starts promptly at 4PM. The gate will be open.

Applications will be filled out and all fees will be paid at this time. During the orientation, the rules and responsibilities of membership will be discussed, along with the safety requirements for use of the ranges.

The one-time initiation fee is \$150 and the annual dues are \$120. Depending on the time of year you join, the dues will be prorated. NRA membership (\$45) is required in order to join the club (bring proof). If the applicant isn't a current NRA member, an application can be made at the orientation briefing.

A background check (a \$12 fee) is required unless the applicant has a Washington State Carry Concealed Pistol permit, or is a member of Washington Arms Collectors. If the applicant fails the background check, only the initiation and annual fees will be refunded.

The payment of dues and other fees are payable at the orientation meeting.

CASH or CHECK ONLY

New members will be voted in at the next general meeting, <u>which the applicant must attend</u>. The general meetings are usually held on the 4th Friday of the month at 7 PM.
