I agree to the Terms and Conditions set out hereunder:

- 1. A current contract is required at the beginning of each season for each mare.
- 1a. A non-refundable booking fee of \$200.00 is deductible from the service fee, and non-refundable, and is required with a new Contract.
- 1b. The total service fee is to be paid on or before the mare's arrival on the property. Please note. Mares will not be served unless the full-service fee has been paid.
- 1c. All veterinary and health expenses (including travel expenses) incurred for the mare/s, including but not limited to; scans, palpation, drugs and pregnancy tests, will be paid for by the breeder. All mares will be inspected for ticks and sprayed if required, and wormed on arrival at the mare owner's expense, and then at appropriate intervals of the stud management's discretion. All Veterinary Accounts will be sent direct from the Veterinary Practice. All accounts for agistment and other associated expenses are to be paid monthly to Dianna Kimball.
- 1e. All accounts and other associated expenses must be paid in full before any mare leaves the property.
- 1f. Provided all money owing and liabilities to the Stud under this agreement are paid, the Stud will upon request will give the Breeder a service certificate.

- 2. Please note that no Contract is said to have been made until the completed Breeding Contract and non-refundable booking fee is received by Dianna Kimball. Payment information is found at the end of this contract.
- 3a. A refund of service fees will be offered if, within fifty (50) days of the last service, Dianna Kimball is in receipt of a Veterinarian Certificate stating that the mare is not in foal. Service Fees transferred from a third part is not eligible for refunds.
- 3b. Refer to condition 9 on Live Foal Guarantee.
- 4. In order to minimise stallion use, maximise stallion fertility and maximise mare conception, Stud Management reserves the right to direct and implement Follicle Testing, Pregnancy Testing and subsequent drug therapy, such as antibiotics, Prostaglandin, Oxytocin, Ovuplant and Flushes. At all times minimising the cost to the mare owner and maximising the successful conception without compromising the mare's wellbeing, which will be the highest management priority. All costs will be met by the breeder.
- 5. Mares must not have hind shoes on if they are to be served and/or turned out in a group. If the mare is shod behind, we reserve the right to remove the shoes with the costs borne by the owner.

- 7. In all cases Veterinary Charges are the responsibility of the owner or agent of the mare. The stud management has the right to call the Veterinarian at any time, for any reason, without consulting the breeder. All reasonable efforts will be made to keep breeders abreast of developments.
- 8. The stud will take all reasonable care but shall not be liable to the breeder in the event of the death of the mare (s) or in the event of the same receiving any injury or suffering any illnesses howsoever arising.
- 9a. There is a Seven Day Live Foal Guarantee for all Services. Dianna Kimball is very interested in breeders getting a live, healthy foal on the ground. In the event of bad luck,

the mare slipping, foaling difficulties, or some other disappointing circumstance the stud should be notified immediately. A Veterinary Certificate stating the mare is no longer in foal, or the foal has died within seven of birth required for a "Free Return".

9b.The Seven Day Live Foal Guarantee, "will be not honoured", when Veterinarian treatment is not sort or provided for the foal.

10. In the event of a Stallion being unavailable – due to death, injury, and competition commitments or sold – Dianna Kimball will offer a full refund.
