



## **TUCSON REPUBLICAN WOMEN STANDING RULES**

- 1. Anyone attending any TRW function must be at least sixteen (16) years of age. The President can grant an exception to this on a case-by-case basis.**
- 2. An active member may attend an Executive Committee meeting as an observer.**
- 3. For luncheons a reservation made is a reservation paid. Anyone who does not cancel lunch reservations by 12 noon the Thursday before the luncheon shall be billed for the full cost of the lunch. Nonpayment will result in not being able to attend luncheons until payment is made.**
- 4. All material purporting to be created by or bearing identification of TRW shall have the prior approval of the TRW President before being printed or distributed.**
- 5. The President shall have a debit card for the TRW account to conduct club business should the Treasurer be unavailable.**
- 6. The TRW dues amount for each Active Club Member shall be \$30.00 annually (this includes \$20 to NFRW and \$4 to AzFRW) and shall be paid to the AzFRW Treasurer by the published deadlines.**
- 7. TRW shall pay an annual club service charge fee of \$15/yr. to NFRW \$10/yr. to AzFRW which shall be payable on or before December 31.**
- 8. Any funds being expended over \$250 must be voted on by the membership if not in the current budget. The exception to this rule is payment for the monthly luncheons.**
- 9. Tucson Republican Women may award scholarships to women who are high school graduates and are attending college or trade school. The recipient must ascribe to Republican values and, if of voting age, be a registered Republican.**
- 10. Lunches for guest speakers will be paid for by the Club. However, Candidates invited to speak will be responsible for their lunch and other related expenses.**
- 11. Membership rosters will be issued to members only. These rosters are only to be used for official TRW business.**
- 12. Cards will be sent to members and associates when ill, having surgery, or upon a death in the family.**
  - a. A \$25 memorial gift shall be sent to the AzFRW Memorial Fund upon death of a member.**

- 13. An allowance of up to \$500 for each AzFRW State Meeting or Convention will be provided for the President or her Proxy's expenses provided the funds are available at the time of the state meeting or convention. Receipts must be turned in to the Club Treasurer for accountability.**
- 14. The President or her alternate shall be issued up to \$1000 for expenses to the NFRW Convention, provided the funds are available at the time of the convention. Receipts must be turned in to the Club Treasurer for accountability.**
- 15. If the President and an alternate both attend the NFRW Convention the alternate's registration fee, up to \$500, will be covered provided the funds are available at the time of the convention. The alternate will have to pay any other expenses out of pocket. If any other fees are paid, it shall require a vote of the membership. Receipts must be turned in to the Club Treasurer for accountability.**
- 16. At the conclusion of the AzFRW Biennial Convention the Club shall pay up to \$100 of the registration fee for all delegates and alternates who attended provided funds are available at the time of the convention. If any other fees are paid, it shall require a vote of the membership.**
- 17. Programs should not include private enterprise speakers, unless subject matter is directly related to the Club's interest.**
- 18. Tucson Republican Women bylaws shall be reviewed at least biennially.**
