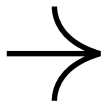

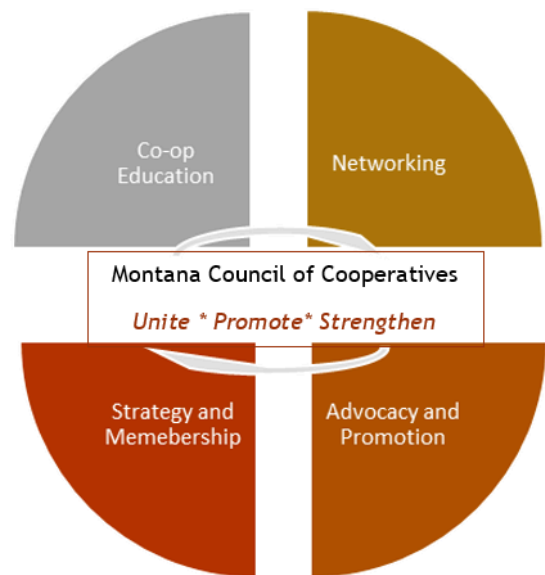
✱ WHAT IS MONTANA COUNCIL OF COOPERATIVES

OUR ORGANIZATION



Serving Montana Cooperatives Since 1960

The Montana Council of Cooperatives (Council) is a statewide organization dedicated to uniting, promoting, and strengthening cooperative businesses across Montana. As a non-sector-specific entity, the Council represents over half of Montana's cooperatives and is growing. The Council offers vital resources and support to foster growth and collaboration amongst Montana's vast cooperative ecosystem.



The Council's work is driven by four key pillars that guide the expansion of services, foster cooperative engagement, and champion innovative legislation to strengthen the Montana Cooperative Community: **Co-op Education, Networking, Strategy and Membership, and Advocacy and Promotion.** Through programs around workforce development initiatives, networking events, and advocacy efforts, the Council boosts the visibility, impact and growth of cooperatives across the state.

➔ TYPES OF MEMBERSHIP

1) **Montana Cooperatives:**

- Credit Unions
- Utility Cooperatives (Electrical and Telecommunications)
- Agricultural Cooperatives
- Multi-sectoral Cooperatives
- Community-based Cooperatives
- Any legally structured cooperative in Montana.

2) **Sponsoring Members:**

- Cooperative Associations within Montana serving Montana Cooperatives
 - This includes other cooperative associations that support Montana Cooperatives (as identified on the next page)
- Out of State Cooperatives or Cooperative Associations
 - These are cooperatives doing business in Montana that want to engage in the Montana Cooperative Community but whose primary office is outside the state.

3) **Associated Members:**

- Businesses/Organizations wanting to do business with Montana Cooperatives



✳ **MEMBERSHIP DUES 2025 AND 2026 +**

1) Montana Cooperatives:

Credit Union and Utility Cooperative Dues are based on the number of members in the cooperative as of January 1st.

\$.075 per member or up to a Maximum Amount:

- Maximum Amount of \$560 in 2025
- Maximum Amount of \$675 in 2026
- Minimum Amount of \$100

All other forms of cooperatives are based on the gross income of the cooperative:

Gross Income	2025 Dues	2026 + Dues
Up to \$15,000	\$100	\$100
\$15,001 to \$100,000	\$110.00	\$132
\$100,001 to \$200,000	\$220.00	\$264
\$200,001 to \$300,000	\$340.00	\$408
\$300,001 to \$400,000	\$450.00	\$540
\$400,001 and over	\$560.00	\$672

2) Sponsoring Members

There are two forms of sponsoring members:

- Montana Cooperative Association dues are \$750/year. Examples of associations are:
 - Montana's Credit Unions and Credit Union League
 - Montana Electrical Cooperatives' Association
 - Broadband MT

* If an association or organization based in Montana would like to apply for this specific membership, they must complete a written statement on how they serve Montana cooperatives and why they would like to be a sponsoring entity.

- Out of State Cooperatives or Cooperative Associations dues are set at \$3,000 a year.

✳ MEMBERSHIP DUES 2025 AND 2026 AND BEYOND

3) Associated Members

Dues are set at \$250 for 2025 and will increase to \$300 starting in 2026.



Two Variances Can Apply to Membership:

1) Any cooperative (in-state or out-of-state) interested in membership can ask for a dues variance based on hardship or the cooperative's size.

To discuss a dues variance, contact MCOC Administrator Tracy McIntyre (tracy@mcdc.coop, 406-727-1517). The final decision is with the MCOC Board of Directors.

2) The Montana Council of Cooperative's sister organization is the Montana Cooperative Development Center (MCDC). MCDC is the economic development branch of the Montana Cooperative Community and utilizes the cooperative business model to address economic and community needs statewide.

Emerging cooperatives that legally form within Montana and were/are clients of MCDC's receive an introductory membership fee of \$50.00 for the first three years after incorporation.

Montana Cooperatives and Sponsoring Members:

Policy and Advocacy

- Support Cooperative Community Policy and Advocacy Work
- Gain access to the biennial Montana Cooperative Economic and Community Impact Report
- Engage with legislative bodies, policymakers, and cooperative leaders to support the cooperative community (in and outside of Montana).

Associated Member Benefits:

The Council's Associated Membership Program promotes and facilitates economic growth in Montana through the cooperative community by engaging businesses, non-cooperative entities, and organizations.

Eligibility and Restrictions

- *Eligibility:* Any businesses, non-cooperative entities, and organizations that are interested in supporting, engaging, and doing business with the Montana Cooperative Community.
- *Restrictions:* Associated members cannot vote on Council business and cannot serve on the Council Board.

Benefits of an Associated Member:

- *Networking: Opportunities:* Access to networking events, national and international co-op leaders, economic opportunities, as well as workshops and seminars.
- *Visibility and Recognition:* Listing on the Montana Council of Cooperatives' website and in the membership directory. Recognition as an affiliated member at events and in publications.
- *Educational Resources:* Discounts on educational programs and resources offered by the Montana Council of Cooperatives.
- *Business Development Support:* Opportunities for business matchmaking and partnerships within the cooperative community. Access to business consulting services and support for cooperative-related projects through the Montana Cooperative Development Center. Note that some services through MCDC may have a fee.
- *Marketing and Advertising:* Discounted advertising rates in Council publications and on the website. Opportunities to sponsor events and programs, increasing your brand awareness statewide.
- *Exclusive Invitations:* Invitations to exclusive Council events, receptions, and roundtable discussions. Opportunities to host or co-host events and workshops. (coming in 2025/26)
