

## **CONSENT TO SUBLEASE**

## Amendment to Lease: (Property Address)

- 3. CONDITION OF THE PREMISES: Sublease Tenant acknowledges that Sublease Tenant was provided with a copy of the joint move-in inspection. Landlord makes no representations regarding the condition of the Premises. Sublease Tenant accepts the Premises as is and agrees that the joint move-in inspection accurately reflects the current condition of the Premises.
- 4. SECURITY DEPOSIT: Landlord has not accepted a security deposit from Sublease Tenant. [OR: Landlord has accepted an additional security deposit from Sublease Tenant in the amount of \$\_\_\_\_\_.] The original security deposit and an itemization of damages will remain on file for the remainder of the lease term and be issued to the original Tenant as specified in the Lease.
- 5. SCOPE OF CONSENT: Original Tenant and Sublease Tenant understand and acknowledge that any agreement between Original Tenant and Sublease Tenant should be separately documented, in writing. In no event shall any separate agreement between Original Tenant and Sublease Tenant be binding on Landlord unless signed by an authorized agent for Landlord. By consenting to the Sublease, Landlord does not waive any rights under the Lease.
