**Cage Birds & equipment check-in**: 3/22 3:30 P. M. - 6:15 P. M. 3/23 8:00 A. M. - 10:00 A. M. Eggs & chicks must be checked in by 9:30 A. M. 3/23.

**Sale Order:** 8:00 A. M. - equipment; **app.** 9:15 A. M. (<u>after equipment sells</u>) - Main arena - poultry, rabbits, pigeons, game birds, & waterfowl; 10:00 A. M. - aviary birds, warm room animals, & equipment app. 11 A. M. chicks & eggs; noon - animals in holding pens.

Kansas Statutes require <u>all poultry</u>, and <u>game birds</u>, <u>regardless of their state of origin</u>, to be <u>PT tested</u> before being offered for sale at any public sale. Test papers must be presented at check-in. Out of state sellers must present an import permit. Call <u>the KS Animal Health Dept at 785-564-6700</u> to obtain an import permit 3 weeks before the auction. Testing information is posted on the club web site: https://hoagbagardnerauction.org

All birds and animals sold at the auction are intended for use as food or fiber/feathers and for improving the breeding and management of the species as per AWA regulations.

New APHIS/USDA Caging Guidelines must be followed or the auction staff cannot accept your consignments. This means NO laundry baskets or cages with solo cups, oleo tubs or cut-off soda bottles being used for feed and water. The complete guidelines are posted on the club's web site and facebook page.

Consignments will be posted on the club's facebook page and web site before the auction.

The cage goes with the bird/birds or animal/s in the cage.

Bids are times the <u>number of birds/animals</u> in the cage.

**Method of Payment**: Cash or <u>Check with a bank letter of credit</u>. **Credit cards (A 3 % charge will be added to the purchase amount.** (If you purchase \$575.00 in birds, etc., your final cost would be \$592.25 with the 3% charge included.)

**Auction Office:** Open Class Building which is the building on the left as you enter the fairgrounds. It is directly across from the building we have used in the past.

**Cancelling the Auction is NOT an Option:** This is an advertised event with potential buyers traveling in from distant states. HOAGBA has no way of notifying all potential attendees of a cancellation so the auction will be held regardless of the weather. The main arena auction of chickens, rabbits, pigeons, game birds, waterfowl, animals, and equipment is held outdoors so dress according to the weather.

- ♦ No one except the consignor or a member of the HOAGBA Executive Board may open a cage for any reason once the consignment process has been completed. Sick, injured, or dead animal/ bird will be removed by the owner or a member or the EB.
- Parents are responsible for their children's safety running on the fairgrounds & jumping off the bleachers is a no no!
- Dogs are not allowed on the fairgrounds unless they are service dogs.
