

Private Client Pre-Investigation Checklist



Before hiring a private investigator, being prepared helps ensure your case is handled efficiently, cost-effectively, and with the best chance of success. Use this checklist to get organised.

1. Define Your Objective
 □ Be clear about what you need (infidelity evidence, custody support, debt recovery, tracing, fraud, etc.) □ Decide whether you need peace of mind, or court-ready evidence
2. Gather Known Information
□ Write down names, addresses, and phone numbers of all parties involved
 □ Collect any photographs, documents, or digital evidence you already have □ Include timelines of relevant events
3. Document Incidents
□ Keep notes of dates, times, and places linked to your concerns
□ Record any unusual or suspicious behaviour
□ Store this securely and do not share with the subject
4. Consider Legal Context
□ Understand what private investigators can and cannot do legally
□ Avoid taking actions yourself that may break the law (e.g. trespass, hacking)
□ Ask your investigator how evidence will be collected lawfully
5. Identify Involved Parties
□ List all individuals connected to the matter (partners, colleagues, family members, etc.)
□ Note relationships between them
□ Identify potential witnesses
6. Review Previous Actions
□ Note any previous investigations, legal steps, or police involvement
□ Provide copies of reports, case numbers, or documents to your investigator
7. Assess Your Budget & Urgency
□ Decide how quickly you need results
☐ Be realistic about surveillance costs, travel, and reporting time
□ Discuss pricing and packages with your investigator before work begins

8. Avoid Alerting the Subject

□ Do not confront	or warn the	person you v	wish to investiga	te

- □ Avoid changing your normal routine in ways that could tip them off
- □ Keep your intentions confidential until evidence is gathered

9. Prepare for Next Steps

- □ Decide if you'll need witness statements or expert testimony
- □ Keep communication open with your investigator throughout

10. Confidential Consultation
