
- 1. Old Business. July 10 minutes approved.

 - 1. Status of the Hilltop Subdivision. The Douglas County BOCC previously rejected Hilltop subdivision request to re-zone the property from Agricultural (A1) to Rural Residential (RR). The developer is now considering the request again for LRR (Large Rural Residential) status. This would be for homes on approximately 10 acres size lots.

Independence (f/k/a Bandera) is a clustered master planned community intended to fit within the natural beauty of northwestern Elbert County. The future development has been designed in accordance with the Planned Unit Development (PUD) that was formally approved in 2009, with reduced lot sizes and clustered density to increase the community's perimeter buffer and adhere to the Elbert County Master Plan. As approved in the PUD, the community is expected to deliver 920 single family homes, an elementary school, parks, trails and several community amenities on central water and sewer services. The purpose of this Community Meeting is to discuss the planned development, the associated plats and the special districts to support it.
