1. The meeting was called to order at 7:00 PM.

## 2. Old Business:

- (1) The minutes of February 9 previously approved required a minor editing change of paragraph 2a. Old Business.
  - (2) The minutes of April 6, 2023 were approved.
- b. 601 Coyote Trail vehicle violation status. The homeowner has violated Article 5.3 D, <u>Storage</u> and continues to violate Article 5.3 E, <u>Parking</u>, <u>Roadway and Other</u>. The homeowner has been sent four more letters informing them of the violations and the failure to pay the remaining or subsequent fines of Article 5.3 E.
  - c. Status/update on the community well/infrastructure purchase.
- (1) Discussion continues on the financial loan type (long or short term) and the financing difficulties related to each.
- (2) The loan and purchase options as to how it may affect the individual homeowner was briefly discussed.
- (3) The Board proposed drafting an email to the HOA homeowners to communicate the situation to all owners and the options for purchase.

- e. HOA community road conditions. No update at this time for the HOA roads. The road closure of parts of county road 13 between county roads 166 and 158 was mentioned due to the recent heavy rains. The same was said for county road 13 between county roads 158 and 86 to Elizabeth.

  - g. Weed control. No issue.
  - h. Any update on the question on equestrian liability? Individual homeowners insurance would apply.
  - i. 650 Coyote Trail status:
    - (1) To install a HAM radio tower. Not approved.
    - (2) To install a green house. The HOA Board has directed them to Elbert County for approval.
