## HMC Tuition Agreement/Parent Permissions (Office Copy)

A NON-REFUNDABLE Registration fee of **\$140** is due upon Registration.

AM 3s and MMO (2 Days):	\$185/month
AM 3s and MMO (3 Days):	\$205/month
AM PreK 4s (5 Days):	\$300/month

- The 1<sup>st</sup> tuition payment (for September) is due on or before May 1<sup>st</sup> to secure your child's place and is NON-REFUNDABLE. *Student must show up for Orientation and begin regular attendance to keep the space in the class.* (Exceptions may be approved by Director.) Nonpayment of tuition by May 1<sup>st</sup> forfeits your child's space in the class.
- Tuition is due by automatic payment through ACH bank draft or Credit/Debit card on the 1<sup>st</sup> of each month, beginning October 1<sup>st</sup> and ending May 1<sup>st</sup>.
- Payment Authorization Form available on website under Enrollment or in the office.
- Tuition is due regardless of child's attendance, school breaks, or inclement weather.
- HMC does not do refunds for snow or inclement weather days.
- A 10% discount on tuition only is applied for families with siblings. Regular Registration Fee is applied.
