## **HMC Tuition Agreement/Parent Permissions (Office Copy)**

A NON-REFUNDABLE Registration fee of **\$150** is due upon Registration.

<b>3s and MMO (2 Days):</b>	<b>\$250/month</b>
<b>3s and MMO (3 Days):</b>	<b>\$275/month</b>
<b>PreK (5 Days):</b>	<b>\$375/month</b>

- The Registration Fee of \$150 will deduct via ACH bank draft the first week of March.
- The 1<sup>st</sup> tuition payment (for September) is due on the first business day of June to secure your child's place and is NON-REFUNDABLE. It will be an automatic ACH bank draft. **Nonpayment of tuition by this day forfeits your child's space in the class.**
- Tuition is due by recurring monthly automatic ACH bank draft on the 1<sup>st</sup> business day of each month, (June for September tuition and Oct.- May)
- A late fee of \$25 will be assessed if an ACH is returned for insufficient funds and payment is not received by the 10th of the month.
- The ACH Payment Authorization Form is available on our website under the Enrollment tab and is due upon Registration.
- Tuition is due regardless of child's attendance, school breaks, or inclement weather.
- HMC does not do refunds for snow/inclement weather days or partial month attendance.
- A 10% discount on tuition is applied for families with siblings. Regular Registration Fee is applied.
