In June 1935, legislation was passed by the Connecticut General Assembly which established the Connecticut Tumor Registry, creating the oldest population-based cancer registry in the nation. As we celebrate our 90th anniversary we are excited to be the host registry for the North American Association of Central Cancer Registries (NAACCR) Annual Conference – the foremost cancer surveillance conference – which will take place at the Connecticut Convention Center in Hartford from June 3rd-5th. The NAACCR Annual Conference brings together cancer surveillance professionals, cancer researchers, and representatives from government agencies, hospitals and medical associations from across the US, Canada and worldwide.

Bylaws Committee:

The updated Bylaws from November of 2024 were reviewed for consistency, and three sections have been identified that need clarification or revision. The three sections are:

- Sections III-V-B and IV-I-B seem to be contradictory. Consistency and clarification needed.
- Section IIB regarding speaker honoraria needs emphasis. The standard honoraria should have been voted on at the Annual Meeting but were inadvertently overlooked.
- Section III, regarding the annual audit likely needs to include a definition of "audit". There may be legal implications when using the term.
- Proposed Additions:
- Article IV-C (new) Membership dues shall be waived for members who volunteer to serve on the Executive Committee. The waiver shall be applied in the year following the member's service.
- ♦ Article VIII-II: [current]: There shall be a Liaison Committee whose function is to coordinate and communicate the activities of TRAC with other Tumor Registrar associations and allied organizations and to inform TRAC membership of related activities and programs offered by these groups. *The Chair of the Liaison Committee shall be appointed by the TRAC president.*

The Bylaws Committee will be working on these revisions and clarifications in order to have a draft for the Spring TRAC meeting.

Readers' Nook:

The Amistad Rebellion, written by Marcus Rediker, takes a fresh approach to the Amistad Rebellion by focusing on the Africans who revolted, rather than the American political and judicial response. Although it's likely that most Connecticut residents are aware that the schooner Amistad is Connecticut's flagship, with its home in New Haven, many of us only know the story of the Amistad rebellion in a brief sense. Reiker's book provides an in-depth view of the work the people kidnapped from Sierra Leone undertook in order to maintain their freedom. Marcus Rediker reclaims the Amistad rebellion for its true proponents: the enslaved Africans who risked death to stake a claim for freedom, Using newly discovered evidence and featuring vividly drawn portraits of the rebels, their captors, brings the Amistad Africans back to center stage. Rediker reframes the story to show how a small group of courageous men fought and won their battle against Spanish and American slaveholders and their governments. The successful Amistad rebellion changed the very nature of the struggle against slavery. As a handful of self-emancipated Africans steered their own course for freedom, they opened a way for millions to follow.
