Members of WFSC who wish to participate in on-ice activities, **must** also be a member of U.S. Figure Skating. Primary members pay their U.S. Figure Skating dues through WFSC. Associate members pay their U.S. Figure Skating dues through their primary club. U.S. Figure Skating membership includes eligibility for Testing, Competitions and a subscription to Skating Magazine. U.S. Figure Skating is the Club's insurance for skaters during club sessions. As a volunteer organization, WFSC requires every skater and/or their parent or guardian to contribute 10 volunteer hours a year. Members who do not fulfill this requirement may need to pay an additional volunteer replacement fee before being able to renew their membership.
