This form must be signed by each volunteer who will participate (Participant) in or otherwise be involved in volunteer activities at the park in connection with Friends of Moody Park (FMP). This includes but is not limited to all efforts to clean or otherwise improve the park and to volunteer shifts at various park events with which Friends of Moody Park is involved. Participants under age 18 must have this form signed by a parent or legal guardian. Parents/legal guardians are responsible for all decisions around supervising or delegating supervision of their minor children (for example, to a troop leader onsite). FMP Board members or FMP-designated event organizers may provide guidance but cannot and will not supervise participants, unless done so as part of another role (for example, as a parent or troop leader).

Sponsors will hereinafter include all, but not only, The City of Houston, Texas, The Houston Parks and Recreation Department, Harris County Flood Control District, Texas Department of Transportation, Friends of Moody Park, and, if participating as part of an organized group, the group named below in the signature area.
