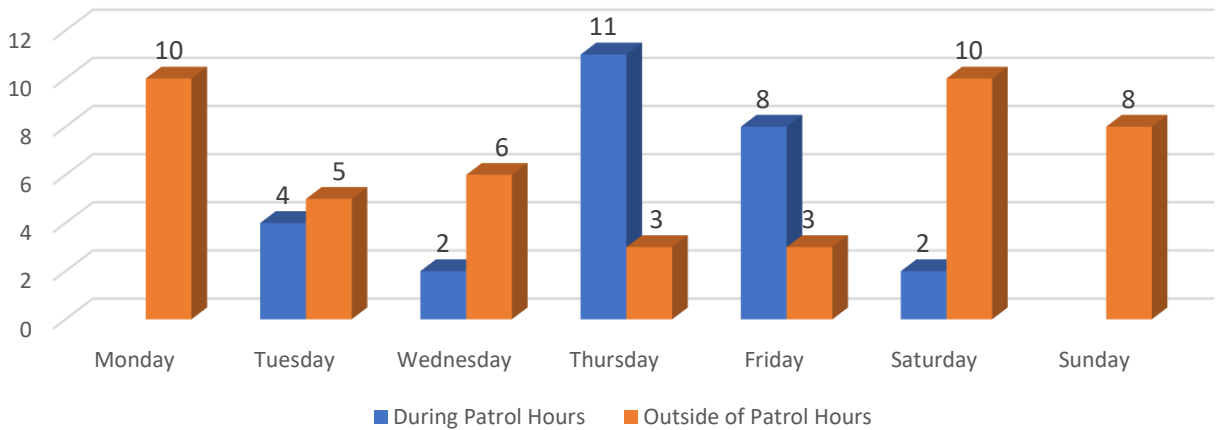

## Crime Comparison During Patrol Hours vs. Outside of Patrol Hours

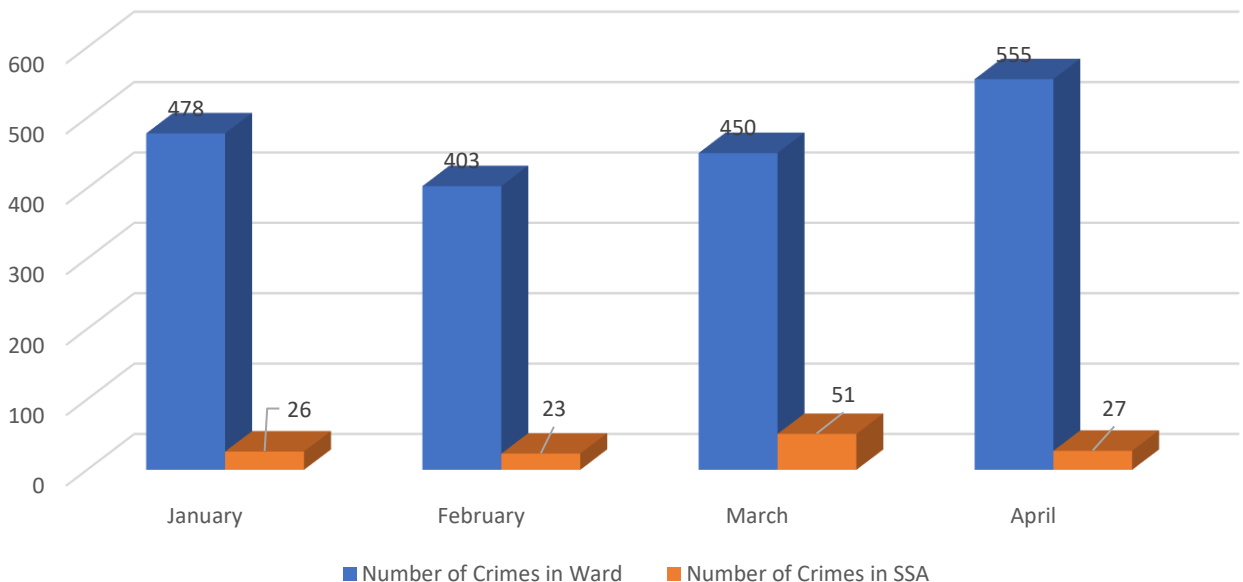


### April Incidents Report

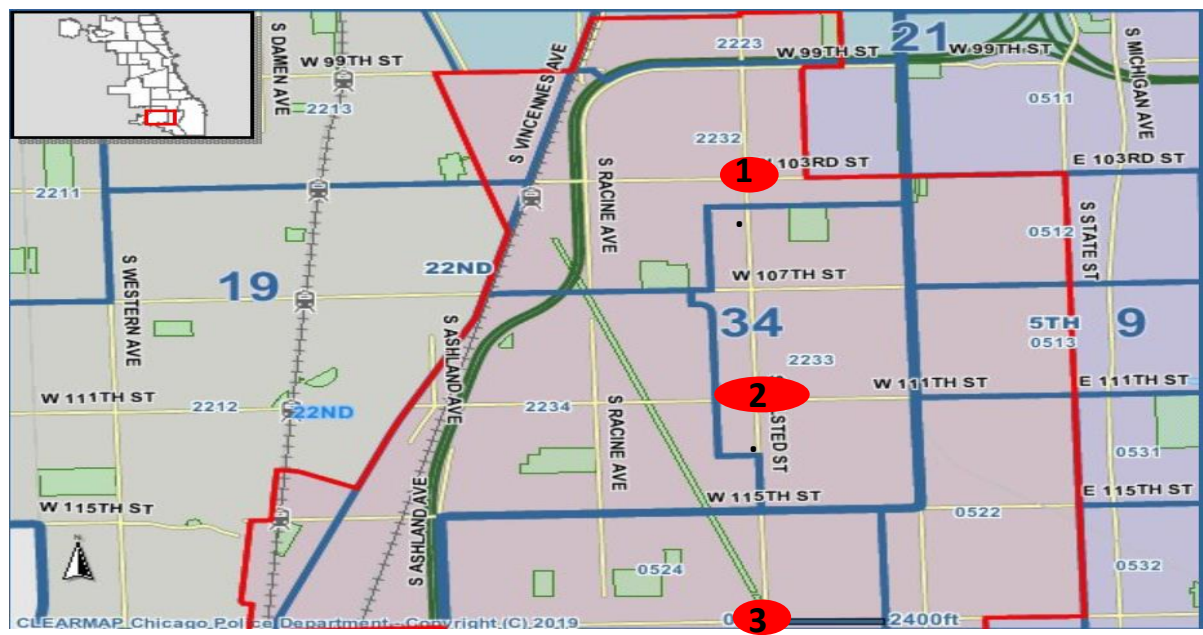
