**SHOW DATE**: Saturday 3/11/2023 from 10 a.m. to 6 p.m.

**LOAD-IN:** Friday 3/10/2023 from Noon -5:30 p.m. Load-in for booths 38 - 45 is 1:00 p.m. -5:00 p.m.

**LOAD-OUT:** Venue must be 100% vacated no later than 9 p.m. on 3/11/2023.

**BOOTH SIZES/COST:** Please refer to www.lasvegasdrumshow.com for the floor diagram.

10'x10' booth: \$325. (Booths 1-19)

10'x12' booth (10' wide x 12' deep): \$350 (booths 21-27 and 30-36)

5'x12' booth (5' wide x 12' deep): \$250 (booths 20, 28, 29 and 37)

7'x10' booth (7' wide x 10' deep): \$225 (booths 38-45). NOTE: This is a lower volume area. No exhibitors with drumsets, snare drums, cymbals or other loud items. This space is reserved for those displaying accessories, artwork, services, or percussion instruments that will not disturb the other exhibitors in this area. Two sets of doors lead into this area from the main ballroom for traffic flow. For clarity, this is a lower volume area compared to the main ballroom and not a quiet space. This area is just outside of the ballroom and a pipe/drape wall separates this area from the student union public space. A security guard will be present at the pipe/drape wall on Friday 3/10/2023 from end of load-in until the student union building closes at 11pm.

## **Cancellation Policy:**

- If cancelled before 10/31/2022, 50% of the booth fee will be refunded.
- No refunds after 11/1/2022
- No refunds will be issued for no-shows.

- I. <u>Force Majeure</u>: This Agreement is subject to the immediate suspension and/or termination (at Las Vegas Drum Room's election) without further obligation on the part of Las Vegas Drum Room and subject to the Cancellation Policy as outlined above, or in the case of any suspension or interference with the Show by reason of labor controversy, strike, earthquake, act of God, governmental action, regulation, or decree, or for any other customary, reasonable, or necessary force majeure reason (in Las Vegas Drum Room's discretion). If the Show is cancelled due to restrictions placed by either local, state, or federal decree regarding the COVID-19 or other pandemic virus, a full refund will be provided.
- II. <u>Table/Chairs</u>: All booths include 1 table and 2 chairs, if needed. You may elect to bring your own.
- III. <u>Electrical Outlets</u>: 110V electrical service is limited. There are wall outlets located around the perimeter of the ballroom space (booths 1-19) and must be shared. There is no electrical service available for booths 20-37. Electrical service is available for pre-function booth spaces 38-45. <u>The use</u> of power strips is not permitted by UNLV.
- IV. <u>Vendor Badges</u>: Two (2) badges are included with each booth. An additional five (5) staff badges maximum may be purchased for \$10 each at the time of registration. If not all names are known when submitting this form, please pay for the badges needed and you may provide names 30 days prior to the show. Badges will not be issued, nor will payments for badges be accepted during load in day or day of show.
- V. <u>Excessive Noise Agreement</u>: As a courtesy to your booth neighbors and attendees, please limit excessive/loud playing to a maximum of 20 seconds. Although playing is necessary to demonstrate sound capabilities of a percussion instrument, jamming, practicing, exhibitionism or excessive rimshot tests interferes with the show experience of others and will not be tolerated.
- VI. <u>Sales Receipts/Collection of Sales Tax</u>: Please provide a sales receipt to your customers for any items sold. Any attendee leaving the venue with equipment will be required to show staff a purchase receipt. Exhibitor is responsible for collecting Nevada sales tax for all transactions. A Nevada sales tax form will be provided to each exhibitor and sales tax will be collected by the Las Vegas Drum Show at the conclusion of the show and subsequently forwarded to the State of Nevada.
- VII. <u>Use of displays, pipe and drape and hanging items:</u> The UNLV Student Union does not allow for the affixing of any items to walls, wall curtains, support posts, doors, windows or window coverings (drapes, etc.). If exhibitor provides their own pipe and drape, it must strongly support the drape and anything attached to the drape. Likewise, any equipment display must be stable without the possibility of tipping over onto your neighbor or any attendee. UNLV will monitor and enforce this on load in day and day of show.
- VIII. Release: Las Vegas Drum Room, LLC shall not be liable for damages to Exhibitor or to any person claiming through Exhibitor for any injury, loss of property, liability, or cause of action due to participation in the Show; this provision includes particularly but not exclusively to all claims arising from the building or any part thereof being or becoming out of repair including equipment, furnishings, fixtures or apparatus located in the detailed premises. The Exhibitor agrees to indemnify and hold harmless Las Vegas Drum Room, LLC, its officers, agents, assigns, employees, contractors, and/or volunteers from any and all claims, causes of action and suits arising or resulting from any damage, injury, or loss to any person or persons, including all persons to whom Exhibitor may be liable under any worker's compensation law or other law and from any loss, damage, causes of action, claims or suits from damage, including but not limited to loss of property, goods, wares or merchandise, caused by, arising out of, or in any way connected with the exercise by exhibitor of the privileges herein granted.

- IX. <u>Damage Liability</u>: Exhibitor agrees to maintain and leave the assigned space in the same condition it was in at check-in and accepts liability for any damage to the premises. Any charges incurred by Las Vegas Drum Room, LLC to repair any damage or otherwise restore the space are the responsibility of the Exhibitor.
- X. <u>Booth Sharing</u>: Booth sharing is permitted (up to two brands/businesses). However, one exhibitor must assume full responsibility for the booth and booth fee. Partial payments from multiple exhibitors for one booth will not be accepted.
- XI. <u>Prohibited Booth Activity</u>: Including, but not limited to, cymbal hammering, drum shell or drum bearing edge cutting, use of electric drills, cutting blades, routers or any activity producing any type of chemical exposure, smoke or sawdust. No activity/tools generating excessive noise other than what is reasonably generated by the playing of finished musical instruments.
