Dr. Mosby completed a 3-year training program and certification in *Gestalt Psychotherapy at Bryn Myr College* in 2014. The main clinical supervisors for this program were David Heinrich, LCSW, Mary Lou Schlack, Ph.D., and Phillip Lichtenberg, Ph.D. He has worked extensively using Gestalt Psychotherapy with numerous clients in the past.

FORENSIC PSYCHOLOGY AND EXPERT WITNESS:

Dr. Mosby has completed more than 1000 Post-doctoral hours of Forensic psychological supervision with Dr. Gerald Vandenburg, ABPP Forensic Supervisor in the Kansas City, Missouri area. He has been qualified in numerous District and Superior Courts in several States. His

expertise has included forensic psychological evaluations, SVP Evaluations, Violent Risk Assessments, custody evaluations, Juvenile Court Evaluations, DCP&P Evaluations, disability evaluations, mental health treatment, Sex Offender Tiering status, Living with Children Evaluations, Megan's Law Removal evaluations, Psychological Reunification Evaluations and marriage/family evaluations. Dr. Mosby completed the *Expert Witness Training Program* (2007) sponsored by the Rutgers School of Social Work Continuing Education Professional Development Department which was funded by the New Jersey Division of Youth and Family Services.

PROFESSIONAL WORK EXPERIENCE:

State of New Jersey

In 1998-2000 Dr. Mosby began working as a clinical psychologist at *South Woods State Prison Bridgeton, New Jersey*. Dr. Mosby was part of the mental health team that helped open SWSP in 1998. As a Staff Psychologist, he completed Psychological Evaluations, individual/group treatment with special needs inmates, in-depth psychological evaluations, detention rounds, parole evaluations, close-constant watches and other psychological duties. SWSP had a population of more than 3,000 inmates in a medium security prison.

From 2000-2001 he was the Lead Psychologist at *Southern State Prison in Leesburg, New Jersey*. The Lead Psychologist is a member of the treatment team which provides psychological services to an inmate population of more than 1600 men. SSCF is a Medium Security Prison. Services include supervision, psychological evaluations, In-depth evaluations, SVP evaluations and treatment services. Southern State Prison is a medium security prison.

In 2001-2002 he became the *Director of Psychology, State of New Jersey New Jersey Department of Corrections Trenton, New Jersey*. The Director of Psychology monitored all Mental Health and Psychological services in NJDOC Prison system in New Jersey.

Upon transferring to the Department of Human Services in 2002 he began working at *Ancora State Psychiatric Hospital from May 2002 to May 2003 as a Clinical Psychologist 1 (CP 1)* Department of Human Services State of New Jersey working on the FORENSIC UNIT Holly Hall B. He became a *Clinical Psychologist 2 (CP 2) at Ancora Psychiatric Hospital* from May 2003 to October 2004 on Holly Hall B at APH.

From October 2004 until September 2007 he was the *Administrator of Psychological Services Chief Forensic Psychologist for the Division of Mental Health Department of Human Services in Trenton, New Jersey*. (Ancora Psychiatric Hospital is now part of Department of Mental Health.)

In September 2007 he transferred back to Ancora Psychiatric Hospital as a *Clinical Psychologist 2 (CP 2)* where he has worked on the *Admissions Unit* and currently on the *Forensic Unit Holly Hall D*. The *Forensic Unit of HHD* currently treats patients who were found NGRI (KROL) for their various crimes. The patients on HHD have been involved with the Criminal Justice System with various crimes such as homicide, kidnapping, burglary, aggravated assault, sexual assault, manslaughter, various CDS crimes and other legal issues. Dr. Mosby retired from Ancora Psychiatric Hospital in May 2020 and works full time in Lifepsych Corp. private practice in Cherry Hill, New Jersey. He has been in private practice at Lifepsych Corp. since 2004.

University Teaching and Private Practice (States of Missouri, New Jersey and Pennsylvania)

Since 2004 he has had a private psychology practice *Lifepsych Corp* in Cherry Hill New Jersey working with the forensic populations, probation, parole, Criminal Justice System, disability evaluations and Gestalt psychotherapy. Dr. Mosby worked as a forensic consultant at Cumberland County Department of Corrections in Bridgeton, New Jersey (Prison Health Services, Inc.) from May 2010 to April 2011. He has taught at *West Chester University West Chester, Pennsylvania* as an Adjunct Professor of Psychology teaching “forensic psychology” courses from May 2011 to May 2014. Prior to moving to the East Coast he taught at *Central Missouri State University in Warrensburg, Missouri* as an Adjunct Instructor of Psychology (1994-1997). Dr. Mosby has instructed courses on the undergraduate, masters and doctoral level and has also been an Adjunct Instructor of Psychology at *Avila College in Kansas City, Missouri 1991-92* and the *University of Missouri at KC in 1991*.

He was the *Director of South Kansas City Outpatient Clinic at the Crittenton Psychiatric Center* in Kansas City, Missouri from 1988-1991. Dr. Mosby was the first Clinical Director of the SKC Outpatient Clinic for the Crittenton Center which was a fully accredited JCAHO Psychiatric treatment facility. The clinic provided a full range of psychological and psychiatric services to emotionally disturbed adults, children, adolescents and their families. He was the *Director of Adolescent Services at Royal Oaks Hospital in Windsor, Missouri* from 1992-1994. The Royal Oaks Hospital was an inpatient Child and adolescent psychiatric hospital providing a full range of treatment. Royal Oaks was a JCAHO accredited hospital.

For many years he was the *Psychological Consultant for the Pleasant Hill School District in Pleasant Hill, Missouri* from 1994-2011. In this capacity he was evaluating children and adolescents for Special Educational Services and violent behavior. He has also worked as a consultant for the Rossi Group doing Parole Evaluations in New Jersey and SVP Evaluations from 2002-2003.

PRESENTATIONS, PUBLICATIONS AND EVALUATIONS:

Dr. Mosby while working in the New Jersey Department of Corrections completed numerous evaluations on violent and sexual offenders. These inmates were maxing out of prison, under parole and also possibly being considered under the SVP Act. During 2004 Dr. Mosby has published two books regarding sex offender evaluation and treatment programs. He has presented training workshops for CEU's for the American Society of Professional Education (ASPE) in such cities as Philadelphia, PA, Parsippany, NJ, Hartford, CT., Baltimore, MD, Silver Springs, MD, Los Angeles, CA and the greater Washington, DC area.

These workshops provided CEU's for psychologists and were approved by the American Psychological Association.

For over two years he was a Clinical Psychologist 1-2 at Ancora State Psychiatric Hospital Holly Hall B, Division of Mental Health Department of Human Services State of New Jersey. During that time, Dr. Mosby was in-charge of the treatment programs for patients that have been civilly psychiatrically committed under Megan's Law Status at APH. At that time, he led four weekly Megan's Law groups with over 57 patients at APH. He regularly provided individual therapy with Megan's Law patients which was been Court ordered in the past. He was also in involved in completing Risk Assessments on Megan's Law patients both at Ancora and in his private office in Cherry Hill. In this capacity he has completed numerous Risk Assessments and evaluations for such issues as recidivism, Tier Level Status, violent recidivism and SVP evaluations. He also has led weekly Megan's Law groups at his office in an outpatient setting as well as co-facilitated group therapy sessions at the Camden County Probation Department Camden, New Jersey and

Burlington County, New Jersey. All risk assessments and evaluations completed include such instruments as WAIS-IV, WASI II, PCL-R-2nd Ed. (Hare), VRAG, HCR-20 v3, MnSost-R, STATIC-99-R, STABLE 2007, VASOR, RRAS, ERASOR, J-SOAP-II, JSORAT-II and other psychological instruments. Dr. Mosby has completed Megan's Law Removal Psychological Evaluations in his private practice through the years. He was the past Director of Internship Training for doctoral level students in psychology at Ancora State Hospital which is an approved APA Internship Program. He is the author of three books, two doctoral dissertations and articles in the field of psychology. Dr. Mosby was the past Administrator of Psychological Services Chief Forensic Psychologist for the Department of Human Services, Division of Mental Health Services from October 2004 to September 2007. Dr. Mosby returned to APH and currently is the Clinical Psychologist 2 at Ancora State Psychiatric Hospital Hammonton, New Jersey on Holly Hall D Forensic Unit. This Unit treats NGRI/KROL patients, Civil Commitment patients, and patients with a criminal history committed to Ancora Psychiatric Hospital. In 2016 Dr. Mosby was invited to lead and participate in a workshop at the New Jersey Judicial College of Courts in Newark, New Jersey at their annual meeting.
