

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK,
AND INDEMNITY AGREEMENT**

In consideration of participating in activities on the property of **Camp Thirsty, LLC**, I represent that I understand the nature of this activity and that I am qualified, in good health and in proper physical condition to participate in such activity including, but not limited to, horseback riding and hiking. I acknowledge that if I believe the activities are unsafe, I will immediately discontinue participation in the activity. I fully understand that this activity involves risks of serious bodily injury, including permanent disability, paralysis, and death, which may be caused by my own actions, or inactions, those of others participating in the activity, the conditions in which the activity takes place, or the negligence

of the Releasees named below, and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the activity. Risks may include, but not limited to, rough terrain and possible injury from the animals, equipment, or trails and terrain such as holes, bumps, ruts, obstacles, tree limbs, rocks, ect. With injuries possibly occurring in remote places without immediate medical care available.

I hereby release, discharge and covenant not to sue **Camp Thirsty, LLC**, their respective agents, volunteers, and employees, other participants, any sponsors, advisers, and, if applicable, other owners and lessors of the premises on which the activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in a whole or in part by the negligence of the Releasees or otherwise, including rescue operations, and further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or costs, which any may incur as the result of such claim.

I have read the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

I hereby release, discharge, covenant not to sue and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS each of the Releasees from all liability, claims, demands, losses or damages caused or alleged to have been caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations, and further agree that if, despite this release, I or anyone on my behalf make a claim against any of the above Releasees, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the Releasees from any litigation expenses, attorney's fees, loss liability, damage, or cost any Releasees may incur as the result of any claim. I further understand that if I participate in activities through **Camp Thirsty, LLC**, I do so at my own risk and understand the inherent risks, hazards and dangers.
