Course: This course is designed to provide basic instruction on the use of the patrol rifle in the law enforcement application. This will be a very informative block of instruction designed to familiarize officers that have been authorized to carry patrol rifles with their design, operation, and theory of use. Basic rifle marksmanship will be addressed with a number of live fire exercises throughout the day. This course will be of interest to all levels of law enforcement and specifically to those who have been issued patrol rifles or are considering adopting them for patrol use.

Basic Equipment needed to bring to class:

- Rifle/Carbine .223/5.56 Ar-15 or Mini-14
- 400 rounds of ammunition appropriate for the weapon. While factory reloads such as Ultramax are allowed, personal handloads are not. If you don't know what that is, please ask.
- Minimum of three, 20 or 30 round rifle magazines
- Duty pistol
- 100 rounds of ammunition for handgun (same reload policy as above)
- Appropriate eye and ear protection
- Appropriate clothing for all weather conditions
