#### Domestic Violence-

This course will meet the mandates for Psychology of Domestic Violence. Students will receive information on the best practices and evidence based investigation of Domestic Violence cases. Conducting impartial investigations will be taught as well as when to arrest and how much evidence is probable cause on domestic violence cases.

Also taught will be the impact on secondary victims such as children of domestic violence and how they are impacted both in the short time and the long term. We will learn how we can help both the primary victim as well as secondary victims of domestic battery.

### Tracy Weaver-

Tracy Weaver is the State's Attorney for the Moultrie County State's Attorney's Office and oversees felony and juvenile cases including Domestic Battery, Violations of Orders of Protection, Aggravated Battery, and child abuse and neglect cases. She is also an instructor at the Macon County Law Enforcement Training Center. Prior experience includes Assistant State's Attorney for Moultrie County where she prosecuted traffic and misdemeanor cases including Domestic Battery and Violation of Order of Protection cases, Assistant State's Attorney for the Coles County State's Attorney's Office, and felony Drug Prosecutor with the East Central Illinois Task Force. She also worked for several years at Illinois CASA, a nonprofit organization which provides support and training to volunteers who serve as advocates for children involved in abuse and neglect court.

### Mary Kroll-

Mary Koll has been a felony violent crimes prosecutor since 2010, first in the Macon County State's Attorney's Office, where she was the supervising attorney of the Domestic Violence Unit and Elderly Victim Crime Unit, and more recently in the McLean County State's Attorney's Office, where she oversees domestic violence prosecutions. In both offices she has also been assigned to other major crimes including first degree murder cases. She is a member of several multi-disciplinary teams that focus on domestic and elder abuse, including founder and coordinator of the McLean County Coordinated Community Response Team and co-chair of the East Central Illinois Regional Fatality Review Team. She has provided training to police officers and professionals across the state on family violence and elder abuse, and is a legal instructor for the Macon County Law Enforcement Training Center.
