#### **Purpose of Course:**

This course is designed to enhance the skill set of tactical team operators in the realm of slow, deliberate room clearing tactics, techniques, and procedures. Emphasizing time, cover, and concealment, participants will refine their abilities to handle various scenarios effectively.

#### **Course Description:**

Join us for a comprehensive five-day training course focusing on systematic room clearing methods tailored for warrant service, barricaded individuals, or situations where dynamic tactics are unnecessary. Following an initial range session, the course primarily takes place in a shoot house environment, utilizing AirSoft weapons and life-size, full-color photo targets. Participants will delve into tactics, coordination, and communication at breach points, as well as follow-on room clearing operations.

Additional topics covered include threat discrimination using no-shoot photo targets and engaging with role players in mini-scenario exercises. The program introduces tactics for dealing with compliant and non-compliant occupants using call-out procedures and less-lethal techniques. Participants will also learn the utilization of ballistic shields alongside covert clearing techniques. The course concludes with three graded scenarios, evaluated by external role-players, to assess the application of learned techniques in realistic settings.

#### **Goals:**

By the end of the course, participants will be able to demonstrate the following:

- Safe and effective close-quarter gun handling skills, including presentations from position 3 with the use of safety and follow-through methods to reapply safety.
- Fundamental skills for doorway threshold clearance during rope drills, encompassing single and double pan methods with coordination with team members.
- Core skills for systematic room clearing methods as part of a team, maneuvering through multiple rooms during exercises.
- Ability to operate a ballistic shield for room clearing operations and provide support to the shield operator as part of a team.
- Target threat discrimination on photo targets and role players, ensuring precise engagement.
- Application of methods for engaging compliant and non-compliant occupants during room clearing operations.

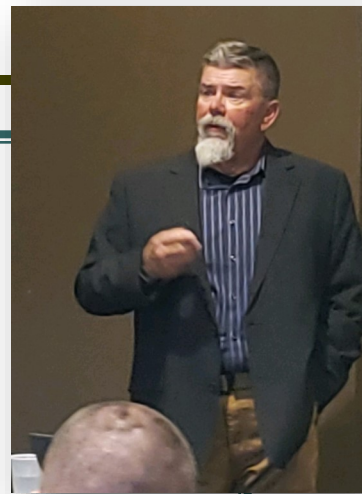
