GOALS: The Goals of the Course are as follows

Ensure each officer is proficient with their rifle/scope combination Ensure each officer knows how to maintain and care for their weapon Ensure each officer is proficient in observation and information gathering Ensure each officer understands proper documentation of records

COURSE PREREQUISITES: Must be a certified police officer in Illinois. Officers should be in good physical condition, this is a physically demanding course and can be stressful, and multiple days of firing in different positions can take a toll on some officers.

GRADING POLICY: This training is performance based, and will require officers to demonstrate proficiency in each of the areas. Course requirements to pass will be as follows;

Written examination - 70% or better

Cold Bore exams - Days two three and four cold bore shots are fired for score and must aver-

age 70% or greater

Final qualification - 100% and you will have three attempts to pass each course of fire

De-Escalation

15.5 hours with 5.5 role play

Ofc. Safety techniques

23.00 hours with 23.00 hours of role play
