Every year, impaired drivers cause thousands of traffic deaths and injuries. Prosecutors and law enforcement officers should realize that we hold the key to winning many of our DUI cases with a very simple tool. That tool is the DUI search warrant.

For the officers: This class will instruct you on how to seek and successfully obtain a DUI search warrant in Refusal cases. You will be given sample complaints and search warrants for DUI alcohol and DUI drug cases. You will be instructed on options available should the offender persist in refusing even after a search warrant is obtained. You will bring a copy of a recent DUI police report and will utilize a template and then create your own documents from that template.

For the Prosecutors: This program will provide you with the tools on how to implement a No-Refusal DUI search warrant program in your area. You will be provided with the information on who needs to be part of the team and what challenges to expect. There will be a step-by-step process provided as well as sample complaints and search warrants for both DUI alcohol and DUI drug cases. You will help review the sample DUI complaints and search warrants that the officers draft in the classroom.

This class consists of classroom instruction and the facilitation of discussion amongst participants on how to design a no-refusal program that fits particular jurisdictions. Participants will also be active in drafting or reviewing drafted complaints and search warrants. **Additionally, participants will be pro-**

Students are asked to please bring a laptop or tablet to class. If you does not have access to one, please don't let that keep you from attending. I have extra laptops or you can double up. Receiving the instruction is more important that physically possessing the electronic device.

Directions:

From Rt. 316 (West State Street in Charleston). Turn South on Decker Springs Road. Take second right hand turn and follow the road around the curve. The training center is on your left.

JENNIFER CIFALDI

Jennifer Cifaldi is the Illinois Traffic Safety Resource Prosecutor and is employed by the University of Illinois at Springfield through a grant from the Illinois Dept. of Transportation. She has held this position since October of 2016. Prior to that, Jennifer served as an Assistant State's Attorney in Adams County, Illinois for 20 years, prosecuting traffic cases at both the felony and misdemeanor level. She also was an adjunct professor at Hannibal-LaGrange University for their advanced degree program in Criminal Justice.

In 2007, Jennifer developed a DUI No-Refusal search warrant model that has now been adopted as the standard for Law Enforcement agencies and Prosecutor Offices across Illinois. She has conducted numerous training sessions on the topic for law enforcement personnel, as well as other prosecutors. Additionally, she has instructed at numerous ARIDE programs and at DRE school.

In the spring of 2018, she worked with Macon County, Illinois to implement forensic phlebotomy for Illinois officers. Jennifer worked with the Buffett Foundation to organize the first ever phlebotomy training by arranging for five officers, a dean from Richland Community College and herself to travel to Phoenix, Arizona and attend the forensic phlebotomy training that Arizona has been utilizing for over 20 years. She is now working with RCC to begin offering classes to Illinois law enforcement officers to become phlebotomists.

In 2016, Jennifer was the recipient of the National Traffic Safety Prosecutor of the Year award. She was also the recipient of the MADD Hero award in 2011 for her work on prosecuting DUI cases. And in 2014, she was awarded the 2014 Murphy Leadership award for her vision, execution and relentless effort to eliminate impaired driving and underage drinking.

Jennifer earned her Bachelor of Arts degree in Law and Society from Purdue University, West Lafayette, Indiana in 1993 and her Juris Doctorate from Valparaiso University, Valparaiso, Indiana in 1996. She resides in Quincy, Illinois with her husband and son.
