Course Objectives- Due to patrol rifles becoming more prevalent in agencies, it is important for officers to learn about the them. Officers will learn how to disassemble, clean, carry on duty, and when to deploy, and basic marksmanship with the rifle. The second objective is to introduce and expose officers with different situations and shooting positions to build confidence while operating the rifle. The third objective is for the student to be able to pass a qualification as presented by the instructor.
