

Day Two- Officer Involved Shootings

- 1. Identify common areas of law enforcement issues of public perception of officer involved shootings to include the renewed "War on Cops".
- 2. Identify the physical, emotional, cognitive, social, departmental, spiritual, and
- relationship changes that may occur during and after a shooting and other dynamics of an OIS.
- 3. Identify methods of securing evidence, getting backup, protect the public and fellow officers, and relay crucial facts to investigators without creating false evidence. These methods include dealing with high stress amnesia, preventing confabulation, and reducing closure.



- 4. Identify healthy methods of coping with the emotional aftermath for the wellbeing of the officer.
- 5. Describe the investigation considerations and to identify problem areas of investigative statements and reports. Describe methods to enhance memory for these statements.
- 6. Identify legal issues such as statutory law, case law, civil law, grand jury and trail issues that result from an OIS.
- 7. Describe the fundamentals of response to news media and how to best protect the department from false news witnesses and reporters.
- 8. Determine when an officer is ready to return to duty, when the officer is not ready for return to duty, and what the department should require before the officer's return.

The instructor is Retired Chief of Police Steven A. Rhoads. Chief Rhoads is a 40 year police veteran with experience in Virginia, Colorado and Illinois. Dr. Rhoads was medically retired as Chief of Police of the Calumet City Police after being injured in an undercover operation.
