**GENERAL INFORMATION** CONTRA® is designed to provide the most critical nutrients that the plant needs to recover from the damage caused by deer and other mammals while also discouraging them from consuming the target foliage. Rabbits, squirrels and other wildlife intent on feeding on leaves, flowers, fruits, seedlings and of small plants, trees and shrubs, will sense the pungency and strong smell conferred by CONTRA®.

#### **MIXING DIRECTIONS** **SHAKE WELL BEFORE USE**

Thoroughly shake the CONTRA® container before use. If applying in combination with other products, always check for compatibility in a small jar test to ensure there is a proper combination of the materials.

#### **DIRECTIONS FOR USE**

**Row Crops:** Apply 16-20 oz of CONTRA® per acre.

**Field Borders:** Apply 32-40 oz with 5 gallons of water per acre when treating the borders of a field. Thoroughly spray CONTRA® on all foliage, including leaves, flowers, stems and branches, targeting the undersides of leaves as well, if possible. Best results are obtained by treating plants before early damage occurs, at the beginning of each season. It is important to re-apply as new growth appears to cover the new foliage or if the effects of previous treatments seem to be wearing-off. Be sure to conduct a test in a small area before widespread use in larger areas to make sure there is no damage to the target plants or crops. The use of a spray sticker adjuvant is recommended in conjunction with CONTRA® for best performance and persistence in aerial and ground applications.

**STORAGE AND DISPOSAL** Store in cool, dry place. Avoid freezing. Store in original container. Keep container tightly closed. Do not reuse empty container.
