#### REPORTS:

- a) Facility Manager's Report: The casters were ordered for the new kitchen range & safety parts for the burner pilot lights are being researched for possible addition to the new range. Tankless water heater prices for Navia brand would be approximately \$907 w/out installation. Installation cost would bring it up to ~\$2k. Sink traps for the community hall will be ordered.
- b) Hall Report: January 16th: Dutch Flat Pool meeting, Jan 27<sup>th</sup> &Feb 3<sup>rd</sup>: private event. Also, the community hall will be used as a voting precinct from March 1-6.
- c) Cal Fire / PCFD Report: Battalion Chief Jeff Loveless gave monthly report:
  - 1) Call Stats for Station 98: 8 traffic, 1 medical rescue, 9 medical
  - 2) Call Stats for Station 33: 8 traffic, 1 medical rescue, 11 medicals, 1 vegetation. Both stations are staffed for winter. Fire hydrant inspections will be conducted on Jan 8th.
- d) Placer Sierra Fire Safe Council Report Jerry Rioux gave a report from Placer Sierra Fire Safe Council

- d) Amended Agenda Item: Change Board Meeting dates for February 1 move to February 8<sup>th</sup>, and July 4<sup>th</sup> meeting moved to July 11<sup>th</sup>. The motion was made by Director Calvert and seconded by Director Mutto. The motion was unanimously approved.
